Purpose of ECI Stakeholders Alliance

The purpose of the Early Childhood Iowa Stakeholders Alliance (ECI SA) includes:

- Overseeing/providing input into the development of a comprehensive, integrated early childhood system for lowa that meets the needs of children ages 0-5 and families, and integrates the early learning; health, mental health and nutrition; family support and special needs/early intervention systems
- Supporting the Early Childhood Iowa State Board in addressing the early care, health, and education systems that affect children ages 0 -5.
- Advising the governor, general assembly, state board, and other public and private policy bodies and service providers in coordinating activities and policies related to Iowa's comprehensive early childhood system.

- 1. Promote a coordinated infrastructure to advance the early childhood system.
- 2. Build public will for investing in young children and their families.
- 3. Transform the early childhood workforce through formal education, greater professionalism, increased skills and competence, and new approaches to implementing best practices.
- 4. Ensure that young children and families receive the services they need when they need them.
- 5. Improve the quality of early childhood services for young children and their families across early care and education; health, mental health, and nutrition; and family support services.
