This rule change implements the ChildCare Assistance (CCA) program. Revising 441 IAC 170 to update family income level to 160% FPL, revise the provider reimbursement rates and to update the minimum hours of participation from 28 to 32 for families who do not have a special needs child. Also, revise the CCA family fee chart to update annual federal poverty level changes.

To allow Iowa teaching hospitals to participate in a Family Medicine/Obstetrics fellowship program. Participating hospitals are eligible to apply for reimbursement for the cost of training and teaching the fellow.
