Making Data Work for You

Use data to support members and heath home initiatives

- Analysis does not have to be formal or through a specific data software to be practical and applicable
- Apply the information gained identify areas of need amongst members and health home team,
- Identify areas or processes that have been successful and have positive impacts
- Analysis can be health-home wide or an on individual basis
 - Has there been an increase in emergency room visits per quarter?
 - Are any members in need of a primary care provider?
 - Has a member been unable to contact two months in a row?
 - Has a member's AIC increased since their last endocrinologist visit?
 - Is there a need to hire more staff in a certain county due to an increase in membership?

Data as a Resource



Start with specific and measurable objectives or goals



Analyze data already generated



Regularly review data and outcomes to improve future decisions

Data Cycle

- Identify a concern or area requiring greater investigation
- **Obtain** data applicable to that measurement
- Analyze data to pull out any trends, insights, or action items
- Use that information to inform decisions and apply changes
- Monitor efficacy of actions taken by reviewing data at scheduled intervals

Obtaining Data

- MCO tools as applicable
 - Availity
 - Health home roster
 - Inpatient roster
 - Service reports
- Quarterly reports
 - Timely care plan
 - Involuntary discharges
 - Exception to policy CMH
 - Care plan revisions

Risk stratifications

- Chart review workbook
 - Overall score
 - Specific measure or subjections
- Electronic health record
 - Contact dates
 - Annual meetings
 - PCP information
 - Individualized tracking mechanisms
- HHS Medicaid Dashboard
- HHS IHH Dashboards coming soon

Analyzing Data

- Time series
 - How have results changed over time?
- Correlation
 - Is there a relationship between variables?
- Monitoring trends
 - Are there any consistent patterns?
- Predictive
 - Can we anticipate what will happen?

Examples – Health Home Wide

Care coordination section of chart review workbook

- Review section score year over year
- Investigate any trends
- If your team has improved over the years, ensure that any steps taken to support members are continued and refined
- If your team continues to struggle in this area, pinpoint potential reasons, consider staff-wide retraining, reach out to MCOs for additional resources

E2 E6 E9 Timely Care Plans

- Examine percentage of timely assessments each quarter
- Has there been a decrease in HAB PCSP timeliness?
- Was there unprecedented staff turnover that identified a need for standardized trainings or tracking?
- Are there any advances that you can make the tracking system or EHR to streamline tracking?
- Does pre-planning begin 60 to 90 days before the due date?


Examples – Individual Members

- Closely monitoring member's Drug Abuse Screener Test (DAST)
 - Identify if there has been an increase since it was last administered and over time
 - Identify that member historically struggles with sobriety in the summer due to a past personal loss
 - Monthly and quarterly visits leading up to the summer can include additional reminders or support group meetings, maintaining therapy appointments, and accessing the community
- For ICM, review documentation and feedback from member's providers on service utilization
 - Has member missed the last few work shifts, which in the past has indicated an increase in mental health symptoms and inpatient stays?
 - Would member benefit from an increase in therapy sessions, alternatives to the emergency room, and aware of crisis services?

Electronic Health Record (EHR)

- Utilize your system for tracking and data collection or generation
- Are there functionalities that could be added to your EHR?
 - Could your organization implement any automated reports or data tracking?
 - Consider connecting with your leadership and IT teams to incorporate some of those metrics into automated functions
- Are there opportunities to improve or advance certain functionalities or the system itself?
 - Adapting to changes in member needs, programmatic requirements
- Do all staff have the full access to needed capabilities within the EHR?
