



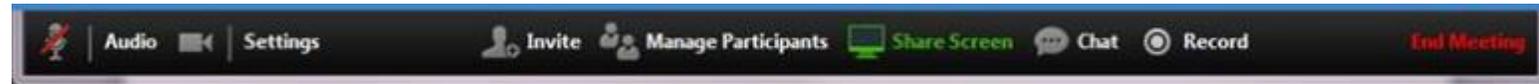

Project Updates

1. Data collection for IBHRS begins in one month with data submission starting in roughly two months. To date, **only three provider agencies have begun XML testing.**
2. Several Provider Agencies must still complete the Basic Certification Form. **Access to UAT cannot be provided until the form is complete.**

Help Desk Questions

Question:

I'm trying to search for a client we have submitted with XML in the test system. When I attempt to search it requires the "Enterprise Unique Identifier". I have tried multiple items from our client data XML, but nothing brings up the client. What am I missing on this?

Answer:

The Client Search report within IBHRS should not require you to enter the Enterprise Unique Identifier to search. FEI will be changing that soon (estimated Friday 6/4).

Help Desk Questions

Question:

Is the XML schema for IBHRS unique to the State of Iowa or has it been vended to other states as well? Checking with our EHR partners to see if this reporting has been implemented elsewhere.

Answer:

The XML datasets and structure are unique to Iowa's Integrated Treatment (SUD/PG) data model. It was built specifically for IBHRS. XML is used across the industry though – it's just the customization/configuration is unique to the Iowa data.

Help Desk Questions

Question:

Can you send multiple records or encounters in the XML files or does there need to be a file for each encounter?

Answer:

You may send multiple records within each XML file. The only limit is that each file must be less than 50MB in size.

Help Desk Questions

Question:

In the IBHRS Submission Guide, ProviderClientPhysicalAddress section it lists the “Second Street Address” field as required. It is fairly common for addresses not to have a second address line and when we submit data to your test system, it passes without a second street address entity. Is the document wrong or is it your test system?

Answer:

The Second Street Address is not required. The Submission Guide will be updated accordingly.

Help Desk Questions

Question:

The IBHRS Vocabulary specification shows a draft revision with a note that a final version was to be released in February. When can we expect a final version of this document to be released?

Answer:

IDPH posted a revised vocabulary file on 5/21/2021.

Help Desk Questions

Question:

In several of the FAQ questions and in the IPN H837P Companion Guide there is mention of “further guidance coming in a future version” (such as how the EUID is found). When can we expect this information to be released?

Answer:

The IPN H837P Companion Guide will be updated in mid-June with this information.

Help Desk Questions

Question:

We are currently using ISMART and use it as a tool to enter our clients and their encounters. We do not use it for progress notes or anything like that. I am confused about IBHRS and how it will affect us.

Answer:

All licensed providers are required to report data to IDPH. IBHRS is replacing I-SMART.

Help Desk Questions

Question:

In the IBHRS Provider Submission Guide, ProviderClientPhysicalAddress entity, there is a notation in the “County Code” element that it is required even if the client is homeless. It seems counter intuitive to ask a homeless client what county their physical address is in when they have no actual physical address. Is this an error in the specification and if not, what county should be sent?

Help Desk Questions

Answer:

County is required for all clients. If the client is homeless, the individual is generally still residing within a specific county. The provider should indicate the most recent county where the client is living.

Help Desk Questions

Question:

If we are doing manual SAE data entry in the new system and the client is not referred to treatment do we only need to do the client data set and the service event?

Help Desk Questions

Answer:

Assessment & Evaluation only programs are required to report all data sets (Client, Treatment Episode, Services). In this case, programs licensed as an Assessment & Evaluation only program, would enter the Client, and the Treatment Episode, including a Care Status of "Pre-Admission", the required Performance Outcome entities for an assessment/evaluation, and the related Service.

Please refer to the IBHRS Provider Submission Guide (Care Status - starting on page 75, and POM - starting on page 83).

Help Desk Questions

Question:

Can you tell me with IBHRS how ASAM and treatment plan reviews will be handled as far as data reporting? Will there be a data entry screen for this? Just trying to prepare with our current EHR how to accomplish this since our system does not integrate IBHRS.

Answer:

Treatment Plans, Treatment Plan reviews and corresponding ASAM information are not reported to IBHRS.

Programs are to continue to have this documentation as part of the clinical record per licensure standards.

Help Desk Questions

Question:

I have been asked if Iowa has plans to 100% require XML and use of the portal or will manual entry into the state portal screens?

While working on this project we had confusion as to our options and timeline while we work to add new questions to our EMR for 7/1.

Help Desk Questions

Answer:

Per the Provider Submission Guide (page 15: 5 Data Submission Options), Licensed SUD/PG providers have two options to report data to IBHRS.

Providers must notify IDPH which option has been chosen:

- A data entry option for those providers that either do not have an electronic health record or choose to report data manually via a data entry screen
- XML file upload for providers with electronic health records that support creation of XML files.
