



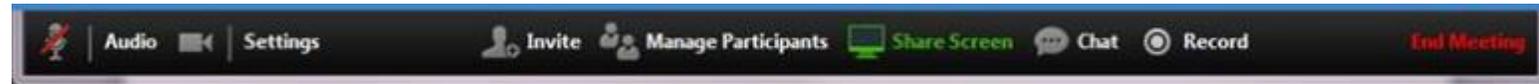

Project Updates

1. Data collection for IBHRS begins in less than two months with data submission starting in roughly three months. To date, **only two provider agencies have begun XML testing.**
2. Several Provider Agencies must still complete the Basic Certification Form. **Access to UAT cannot be provided until the form is complete.**

Help Desk Questions

Question:

I have a question regarding the transition from data only reporting in ISMART to reporting in XML. I understand we need to discharge the clients who are currently in TX by June 30. I think this may take me more than one day so can I plan for two days?

Answer:

Yes. It is recommended the discharge be completed in I-SMART at the time of the last treatment session in June, as the discharge date is the last date of contact.

Help Desk Questions

Question:

What happens in July? Is the data for July entered through XML in August?

Answer:

Data collected in July is to be submitted via XML or Data Entry screens after go live in August.

Help Desk Questions

Question:

I have read the transition guide and still have questions. We have to discharge all open cases in ISMART by June 30. Correct? and after that there will be no data entered via ISMART - is that correct? I am sorry but do not see a timeframe when we can discharge in June.

Help Desk Questions

Answer:

This depends on the way in which you are submitting data to I-SMART / CDR today, and what your plans are for submitting / entering data in IBHRS. IDPH / FEI will cover the transition plan in further detail in an upcoming webinar.

Question:

Which paper forms should be used for an assessment only program?

Answer:

All three paper forms are relevant:

- IBHRS Client Data Entry Form
- IBHRS Service Event Data Entry Form
- IBHRS Treatment Episode Data Entry Form

Also reference:

- IBHRS Data Entry Vocabulary Key (reference guide)

Help Desk Questions

Question:

Can you please clarify which of the events will be required for assessment only services? The service event data set states “a specific TREATMENT encounter..... as part of their TREATMENT program” client data set states required for “each client that receives TREATMENT services from a provider agency” and so on.

Help Desk Questions

Context:

Description

A **Service Event** record represents a specific treatment encounter for a client with a substance use, problem gambling, or other disorder, in a provider site as part of their treatment program. A **Service Event** record will be uniquely identified in the IBHRS by the combination of the Provider's Source Record Identifier for the **Service Event** record and the Source Record Identifier for the Provider. Providers are required to submit a unique Source Record Identifier for **each Service Event** record within each Provider. Therefore, no two **Service Event** records can be submitted with the same Service Event Source Record Identifier and Provider Source Record Identifier combination.

Help Desk Questions

Answer:

There is no requirement or business rule that any particular Service Event is required for any particular type of Treatment Episode. That said, the language of the Submission Guide uses "Treatment" broadly to include assessment activities.

A "Treatment Episode" does not mean that a specific treatment was provided to a client, and a "Client Record" does not necessarily mean that the client was treated; within the context of the Submission Guide, a Treatment Episode could include only assessment activities.

Help Desk Questions

Question:

Is there going to be a live-hands on training for this system? I have been watching the zoom meetings but of course nothing is very clear until I can do something myself to fully know if I understand it. We currently use ISMART as our main documenting system and we do not have an EHR that is capable of working with IBHRS to supplement this change over. (We are getting a new EHR system next year hospital wide that may be compatible) Want to make sure I do not miss any steps in the cross over.

Answer:

I noticed in the 837 example, that loop 2010BB Payer Name has an N3 and N4 segment, but those are not listed above in the companion guide. Are these required? If so, what should they be?

Answer:

They are not required, and the system will ignore them if included.
