 - **Description**: Review of IPN Problem Gambling Treatment expectations, eligibility, services (outpatient, IOP, and Early Intervention), data entry (I-SMART), data integrity, 30 day follow-up, and available counselor/clinician resources.



- Gambling 101 Part 1: Similarities/Differences between SUD/PG (Jerry Bauerkemper)
 - Wednesday, February 20, 2019 (12-1:30)
 - **Description:** Review of the V-Chart (addiction and recovery), stages of a gambling disorder, use of the ASAM criteria; gambling across the lifespan; comorbidity with SUD, Mental Health, and Suicide Risk; and, learning the "lingo" of problem gambling treatment (what, where, how, when regarding the language used).



- Gambling 101 Part 2: Gambling Treatment Tool Kit (Jerry Bauerkemper/Jessica Hartz)
 - Thursday February 21, 2019 (1:30-3:00)
 - **Description:** Review of screening and brief intervention tools (BBGS, DG-SPS, etc.) and techniques; explore "Tips of the Trade" including the Gambling Pathways Questionnaire, Medication Assisted Treatment, working with family members, and how voluntary self-exclusion fits into treatment.



- Best Practices for Problem Gambling Intervention and Treatment (Nic Foss)
 - Wednesday, February 27, 2019 (12-1:30 PM)
 - **Description**: Orientation to best practices for problem gambling treatment, including the use of "Choices" (Note: We hope to have a later training by the author, Dr. David Hodgens later in the year) and use of Motivational Interviewing. Participants will learn skills and techniques on how to implement best practices and effective intervention techniques.
