National CASA/GAL Association news:

- Local Program Highly Effective "on-site" (virtual) reviews are still slated to start in 2024, although no time frame has been announced.
- All 12 programs have submitted membership renewals with National CASA. The invoice for annual membership dues has been forwarded within HHS for approval and payment.
- Local programs and CASA Unit Supervisor are preparing for the 2023 National CASA
 Annual Survey. Typically, annual surveys are released in mid-January and programs have
 until mid-March to complete. There will also be a 6-month statewide aggregate report
 due to National CASA at the beginning of January reporting on CASA data from July
 through December 2023.
- National CASA Association status with their primary federal funder the Office of Juvenile
 Justice and Delinquency Prevention (OJJDP) remains unknown at this time. They are not
 opening any grant cycles, but remain committed to conducting the Local Program Highly
 Effective Reviews.

CASA Program Status Report, December 2023

FY2024 CASA of Iowa planned initiatives:

- The CASA Program Committee has resumed in FY2024. This year's primary focus will be on:
 - aligning CASA Program policies with HHS policies, including Human Resources (staffing and volunteers), Compliance Division policies and Child and Family Wellbeing policies
 - defining what makes a court report to be of quality, then developing and implementing a quality assessment tool
 - The Board approved the CASA Program Policies in December 2022, effective January 2023. Although there are high-level changes that need to occur due to HHS alignment, CASA Unit Supervisor does not foresee a new Program Policy Manual release in 2024 unless changes in code or rules dictate the need for more immediate focus.
- The CASA child well-being assessment series pilot continues in two counties. State
 Organization CASA program staff are meeting with HHS to learn more about assessment
 platforms (other than Survey Monkey) and reporting software that will aggregate and
 create meaningful data reports. This could change the path of this project moving
 forward.
- Assessing current CASA service delivery locations based on court adjudication data to
 ensure our limited staff resources are utilized in the locations with the most
 opportunities to serve children and recruit volunteers. This work includes decisions on
 placement of the VOCA-funded position and potential CAMS changes needed for VOCA
 reporting.

Additional long-term initiatives for CASA of Iowa Programming:

- Improving volunteer participation in continuing education as means to improve advocacy and help CASA of lowa meet the NCASA continuing education standard
- Continued work towards diversification of CASA volunteers. Would like to begin work with different teams in HHS to review and rewrite our DEI plan.
