### Current Child Care Climate

Quantity of registered child development homes is decreasing

A decrease in family child care is a national trend

Licensed child care centers are making up for the deficit by utilizing supports such as:

- Child Care Challenge Grants/Investing in Iowa's Child Care collaboration with Iowa Workforce Development
- Recruitment and retention bonuses
- Increased allowable ratios

Staffing remains an issue, resulting in waiting lists for families



#### Initial Eligibility for Child Care Assistance (CCA) Program

- Increased the "front door" from 145% to 160% Federal Poverty Level (FPL)
- For the average CCA family (1 parent & 2 children)
  - o 145% FPL= \$36,047 per year or \$3,004 per month (approx. \$18.78/hr)
  - o 160% FPL= \$39,776 per year or \$3,315 per month (approx. \$20.72/hr)

#### Work Hour Requirement

- Increased minimum requirement from 28 to 32 hours per week
- If child has special needs the requirement remains at 28 hours per week

#### **CCA Provider Rates**

- Solidified provider rates in code
- Increased rates from 50<sup>th</sup>-75<sup>th</sup> percentile to 65<sup>th</sup>-80<sup>th</sup> percentile of the 2020 Market Rate Survey (MRS)
- Note: Federal regulations require this code to be updated once the 2023 MRS is completed.

### Special Needs

- 441.170 defines "child with special needs" as a child with one or more of the following:
  - Diagnosed with developmental disability which substantially limits one or more major life activities, requires professional treatment, assistance with self care, or purchase of special adaptive equipment
  - Qualified intellectual disability impairing intellectual and social function
  - Diagnosed to have a behavioral or emotional disorder characterized as situationally inappropriate behavior which deviates from age appropriate behavior and interferes with intellectual, social, or personal adjustment
- 633 children are currently flagged as Special Needs
- 105 children get the higher payment rate
- Provider submits documentation that child meets definition to receive enhanced rate and a description of the needs including, but not limited to, adaptive equipment, reduced ratio, or special staff training



### Market Rate Survey/Narrow Cost Analysis

## Federal Requirements HHS must complete:

- Market Rate Survey
   (MRS)=survey of what providers charge families
- Narrow Cost Analysis
   (NCA)=analysis of what it
   costs providers to deliver child
   care services to families
- Note: emerging national data would suggest NCA numbers will be greater than MRS numbers.

### 2023 MRS/NCA

- Contract with ISU to collect and analyze the data and draft the report
- Will have a document with financials ready for 2024 legislative session
- Full report expected May 2024



### Child Care Assistance (CCA) Pilot

One year pilot allowing child care workforce to apply for CCA for their own children regardless of family income

• Over 1,400 children currently served

Must be in a direct care position at the child care program

Must meet all other CCA eligibility requirements





### **CCA Pilot Survey Responses**

92%


of respondents were already in the child care workforce when they applied for the CCA Pilot

- Of those, 88% indicated that the Pilot encouraged their continued employment in child care
- 46% previously applied for CCA but were denied for being over income

#### **RECEIVED CCA**

Indicated they began working in child care as a result of the Pilot




37%

### Iowa Quality For Kids (IQ4K) Updates

## IT system developed to support IQ4K

- All forms and resources are online
- Programs apply online and submit applications electronically

Focus on supporting continuous quality improvement across all categories of programming

Specialized tracks efficiencies (NAEYC Accreditation, Head Start Performance Standards, IQPPS, etc.) Two dedicated IQ4K Specialists in each of the five Child Care Resource & Referral regions to support programs through the application process

### Iowa Quality For Kids (IQ4K) Cont

- Participation is voluntary
- IQ4K eligible facilities include:
  - Licensed child care centers
  - Preschools
  - Programs operating under the authority of an accredited school district or non-public school
  - Registered Child Development Homes
- Programs can achieve up to five levels of quality
- Child Care Resource & Referral provides consultation and targeted technical assistance free of charge to eligible programs
- IQ4K applications are submitted to HHS through the program's regional Child Care Resource & Referral office


Nutrition and Physical Activity	Food Safety Training, Nutrition and Physical Activity Self Assessments and Action Plans, CACFP participation, Nutrition training				
Professional Development	Professional Development Plans, IQ4K identified trainings, additional training hours				
Family and Community Partnerships	Orientation with families, family partnership/engagement activities, family conferences, culturally sensitive practices				
Environment	Enhanced policies, interaction self assessments, program assessments, ERS training and tools, CCNC tool, diverse environments				
Leadership and Administration	Training, education, years of experience for program administrator, evaluations for staff				
Teaching Staff/Provider Qualifications	Training, education, years of experience for teaching staff/provider				
Teaching and Learning	Enhanced policies, curriculum, screening tools, assessments, using and sharing community resources, inclusive practices



### QRS Rated Programs by Level


### QRS Rated Programs As of 12/15/23
