COMES NOW the Iowa Department of Public Health ("Department") and Molly Reinking ("Appellant"), and pursuant to Iowa Code section 17A.10 and 641 Iowa Administrative Code 131.12(7) enter into the following settlement of this matter:

- On October 20, 2017, the Department issued a Notice of Proposed
   Action: Probation, directed to Appellant.
- On November 7, 2017, Appellant requested a hearing regarding the proposed probation.
- The Department of Inspections and Appeals has scheduled a contested case hearing on January 29, 2018.
- 4. Appellant hereby withdraws her request for appeal in the above-captioned matter. Execution of this Consent Agreement by all parties constitutes the resolution of this contested case. Appellant waives the right to hearing and all attendant rights, including the right to appeal, by freely and voluntarily agreeing to this Consent Agreement.

- 5. This Consent Agreement is subject to approval of the Department. If the Department approves this agreement, it becomes the final disposition of this matter. If the Department fails to approve this agreement, it shall be of no force or effect to either party.
- 6. This Consent Agreement shall be part of the permanent record of Appellant and may be considered by the Department in determining the nature and severity of any disciplinary action to be imposed in the event of any future violations.
- This Consent Agreement and the Notice of Proposed Action are public records available for inspection and copying in accordance with the requirements of lowa Code chapters 22 and 272C.
- 8. The Department's approval of this Consent Agreement shall constitute a FINAL ORDER of the Department and constitutes final agency action in this matter.

  IT IS THEREFORE ORDERED:
- The Department rescinds the Notice of Proposed Action: Probation issued
   October 10, 2017.
- 10. Appellant agrees to voluntarily surrender her EMT certification number EMT-12-1013-05. Appellant voluntarily surrenders her EMT certification to pursue a career in another health-related field. By so doing, Appellant does not admit the allegations contained in the Notice of Proposed Action: Probation and enters into this Consent Agreement for the sole purpose of resolving this matter to avoid the burden, expense, delay, and uncertainties of a contested case hearing.
- 11. By voluntarily surrendering her EMT certification, Appellant agrees not to use any words or titles which imply or represent that she is a certified emergency

medical care provider as defined in 641 IAC 131.1, or to otherwise hold herself out to the public as an emergency medical care provider or to engage in the provision of emergency medical services for which certification is required in the state of lowa.

12. Appellant may apply for reinstatement one year from the date of execution of this agreement pursuant to the provisions of 641 IAC 131.9.
