## Qualified Residential Treatment Program (QRTP)

A Foster Group Care Services State-licensed and Accredited Out-of-Home care facility that provides continuous, 24-hour care and supportive services to Children in a residential, non-family home setting.

Court order via Child In Need of Assistance (CINA) or Delinquency

- HHS responsible for contract
- Facilities are required to have a license per HHS contract.

## Shelter

the temporary care of a child in a physically unrestricting facility at any time between a child's initial contact with juvenile authorities and the final judicial disposition of the child's case. "Emergency Juvenile Shelter Care" is the provision of Emergency, short-term care until a more permanent living arrangement is possible.

Children can access temporary (47 hour) placement via JCS, HHS, or Law Enforcement referral, or longer-term placement via court order under CINA or Delinquency.

- HHS responsible for contract
- Facilities are required to have a license per HHS contract.

## Detention

the temporary care of a child in a physically restricting facility designed to ensure the continued custody of the child at any point between the child's initial contact with the juvenile authorities and the final disposition of the child's case.

Temporary placement via JCS or Law Enforcement referral, or longer term placement via court order under Delinquency. Not for CINA youth unless they are also delinquent or placed by law enforcement.



JCS

Adjudicated delinquent and youth at risk of delinquency

- County boards establish and oversee detention centers.
- Required to maintain a license
- No contract
- HHS oversees a detention home fund (CJJP) and counties have to pay a share

## State Training School

Provides a continuum of supervision and rehabilitation programs, which meet the needs of male adjudicated delinquents in a manner consistent with public safety. These services and programs individualize treatment and control the offender for their own benefit and the protection of society.

Child is at least 12 year of age and has been found to have committed a serious crime as described in Iowa Code Chapter 232. Placement via court order.

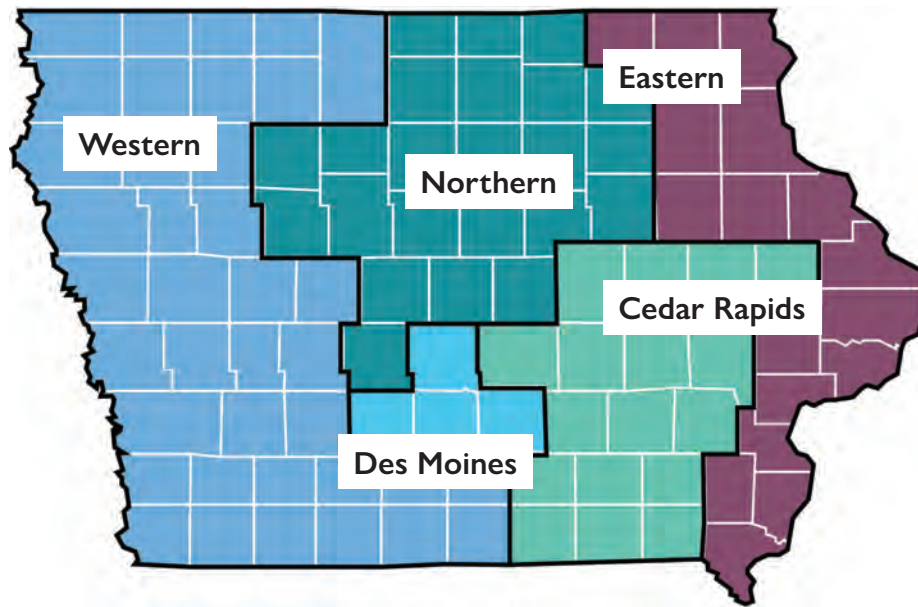

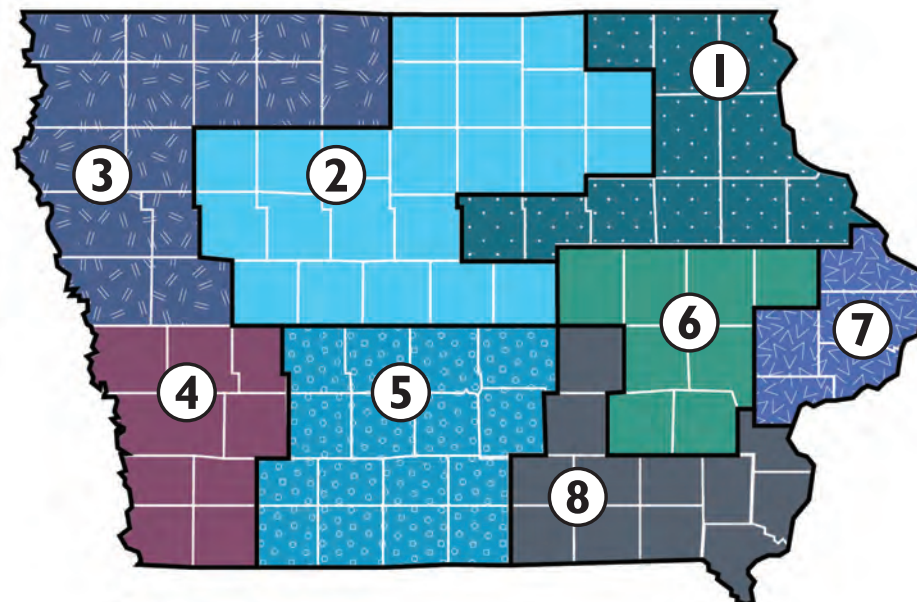

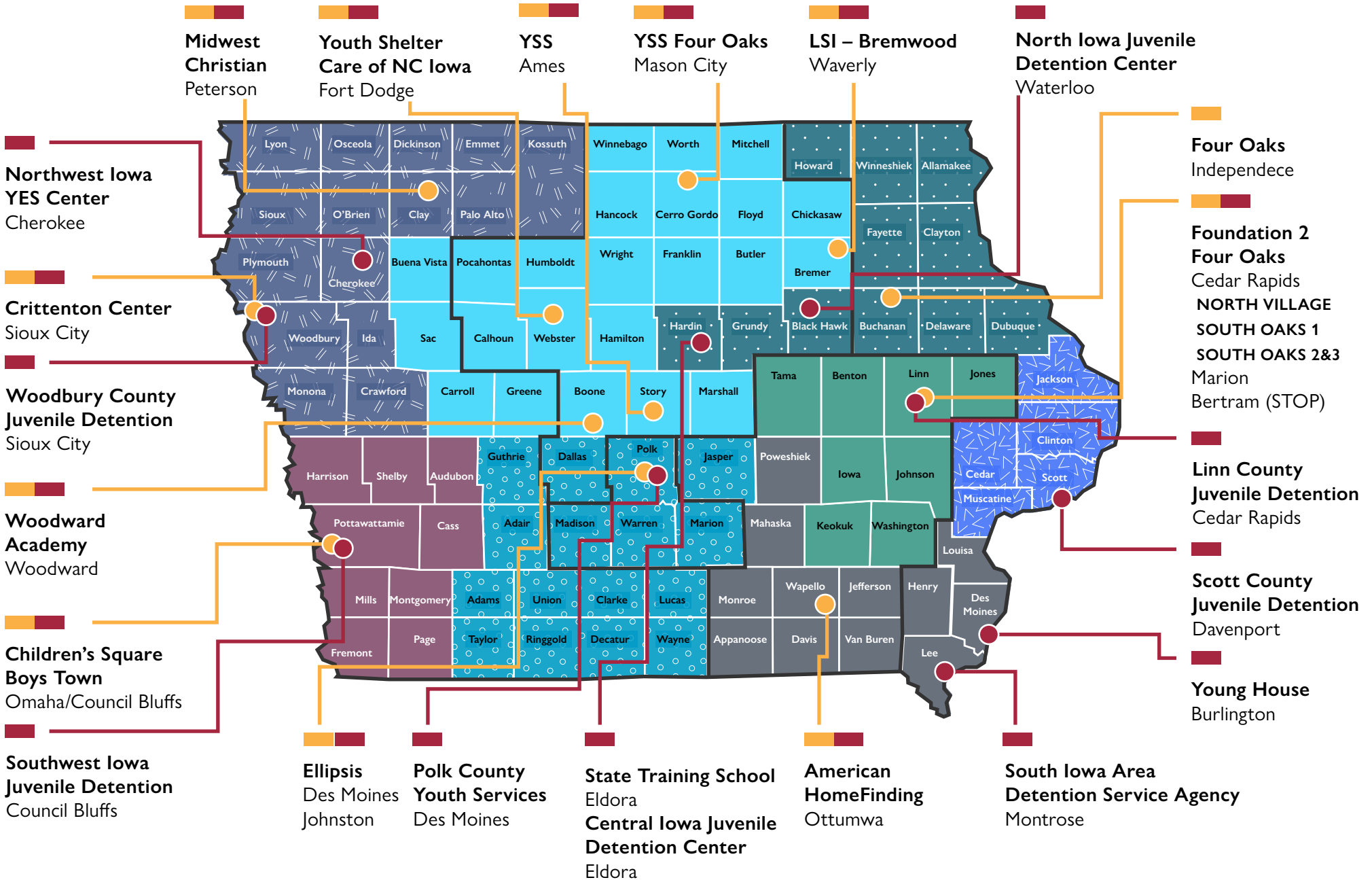
