Who's on the Executive Council?

HSB126

Division I – Dept of Health and Human Services

(Incorporates Iowa Dept. of Public Health, Aging, Human Rights, Early Childhood Iowa)

Primary responsibility for services to individuals to promote the well-being and the social and economic development of the people of the state.

Supervision of public health programs, promotion of public hygiene and sanitation, treatment and prevention of substance use disorder and enforcement of related laws.

Leadership and program management for programs which serve the older individuals of the state.

Services relating to Latino persons, women, persons with disabilities, community action agencies, criminal and juvenile justice planning, African Americans, deaf and hard of hearing persons, persons of Asian and Pacific Islander heritage and Native Americans.

Each state board, commission, department and division of state government and each institution under the control of the Dept of HHS, IDOC, State Bd of Regents and each division of IDOT Required to keep a written, detailed, up-to-date inventory of all real and personal property belonging to the state and under their charge, control and management (has to be in the form prescribed by the Director of Dept of Admin Services)

Pg. 1 – LSA and IHHD will be responsible for criminal and juvenile justice planning and shall develop a protocol for analyzing the impact of the legislation on minorities

- The executive council shall receive requests from the IHHS relative to the purchase, storing and distribution of vaccines and medication for prevention, prophylaxis or treatment. The expense may be approved and payment authorized by the Executive Council
- 2-4 Present principal state departments listed
- If the appropriation of a dept, institution or agency is insufficient to property meet the legitimate expenses of the dept, institution or agency, the director with the approval of the governor, make an interdepartmental transfer from any other dept, institution or agency of the state having an appropriation in excess of its needs, of sufficient funds to meet that deficiency. Each school district shall have a qualified guidance counselor licensed by the Board of Education Examiners. Each school district shall have a school nurse. 1 for every 750 students

The school district or accredited nonpublic school makes every reasonable and good faith effort to employ a teacher licensed under _____ for the specified subject and is unable to employ such a teacher.

Within the Banking division – the Professional Licensing and Regulation Bureau

Director may establish a tax-sheltered investment program for eligible employees – with the provision of investment vehicles – recommended for inclusion by a licensed producer or registered as a securities agent or investment advisor representative by the insurance division of the Dept. of Insurance and Financial Services. Total number of insurance companies and investment companies limited to 30. The tax sheltered investment program - eligible public employees in the state of lowa.

Each division within the Dept. of Insurance and Financial Services is an Agency – and each bureau within a division.

A joint investment trust shall file the audit reports.

Fraud bureau within the Insurance Division

An insurance company or insurance holding company is subject to regulation by the Insurance Division.

Commissioner of Insurance -The administrator shall appoint a deputy administrator who is the principal operating officer of securities and regulated industries bureau and the routine administration of this chapter. The administrator can hire attorneys, accountants, officers and other employees as needed.

An insurance division is established within the Dept. of Insurance and Financial Services to regulate and supervise the conducting of the insurance business in the state of Iowa. The Commissioner of Insurance is the chief executive. The Commissioner of Insurance will also serve as the Director of the Dept. of Insurance and Financial Services. Expenses and salary.

Law enforcement authority.

The Insurance Division shall administer the program in cooperation with the agency responsible for medical services within the Dept. of Health and Human Services. Rules outlined.

Supt. of Banking – The banking division is created within the Dept. of Insurance and Financial Services.

Administrator means the superintendent of banking and superintendent of credit union services.

Credit union division is created within the Dept. of Insurance and Financial Services.

Fees to state treasurer.

Dept. of Insurance and Financial Services Commerce Revolving Loan Fund.

DIVISION XVI – DEPARTMENT OF CORRECTIONS JUDICIAL DISTRICT DEPARTMENTS OF CORRECTIONAL SERVICES AND COMMUNITY BASED CORRECTIONAL PROGRAMS

The Department of Corrections which has primary responsibility for corrections administration, corrections institutions, prison industries, judicial district departments of Correctional Services and the development, funding and monitoring of community-based correctional programs.

The Dept of Corrections may provide either individually or collectively through a 28E agreement, for the establishment of a force of reserve peace officers. In the case of the state, the dept. of public safety shall act as the governing body.

Reserve peace officers shall serve as peace officers on the orders and at the discretion

Employee – pay. The Board. The chairperson. Appointment of Directors. Definitions.

Judicial district director appointed by the Iowa Dept. of Corrections.

Judicial district "advisory" council. District Dept means a judicial district. District departments established and are under the direction of the Iowa Dept. of Corrections. Governor shall establish a salary range for non-elected officers. Different persons make the decision on the salaries of other employees. There is a set of 4 ranges for salaries – Range 4,5,6 and 7. The employees who would be eligible for each range level are identified.

1537 DIVISION XIX – BOARDS AND COMMISSIONS

A Boards and Commissions Review Committee shall be established to study the efficiency and effectiveness of each Board, Commission, Council, Committee or similar entity established by the state in Code. The committee shall evaluate the extent to which the goals and objectives of those entities are currently being met and make recommendations for the continuation, elimination, reorganization or consolidation of those entities as needed. 6 voting members and 4 ex-officio non-voting members.
