MHDS Region movement 7-1-2023





MHDS Regions Began Operations on July 1, 2014

- Local access to uniformly defined services
- Regional administrative structure
- Statewide standards
- Counties joined operations & funds through the 28E process
- I3 MHDS Regions; Polk exempted to be a single county region
- Population ranges from 28,850 to 610,705*
- Intensive Mental Health and Crisis services added in 2018
- Children's Mental Health System core services added in 2019

* based on the 2022 census estimate

Role of MHDS Regions

- Payment for services for eligible persons when payment through the medical assistance program or another third-party payment is not available.
 - Individuals in the process of enrollment for Medicaid
 - Individuals not eligible for Medicaid (e.g., justice-involved)
 - Services not covered by Medicaid
- Development of services to meet the needs of residents of the region.
- Development of the provider network to ensure that services are accessible throughout the region, regardless of payment source for the service.
- Assist individuals in enrolling for Medicaid and other available benefits.

Regional Governance Structure

- HF471 was signed by Gov. Reynolds on 6/1/23 & became law 7/1/23
- Mandates changes to Regional Governance Structure
- Regional governing board
 - Members representing the boards of supervisors of counties comprising the region-shall not exceed forty-nine percent of the total board membership
 - One adult service recipient or involved relative of a service recipient
 - One member representing children's education
 - One parent or involved relative of a child service recipient
 - One member representing law enforcement
 - One member representing the judicial system
 - One member **each** representing adult & children's service providers
- Each member of the governing board shall have one vote
- Adult and Children's advisory committees

MHDS Regions Funding

- Regions were previously funded by a county property tax levy
- Beginning with SFY 22, funding began to shift towards state dollars. By SFY 23 MHDS regions were 100% State-funded.
- SFY 24: \$127.7 million State General Fund appropriation.
- Most, but not all Regions have accumulated a fund balance; excess funds are directed to Incentive Fund, \$26.5 million in SFY 23.
- MHDS Region Incentive Fund to support quality & non-core services, SFY 24 starting balance of approximately \$29.5-million.
- In SFY 22, MHDS Regions funded services for 32,456 individuals with total expenditures of \$128,536,527.

 Of the total individuals, 3,776 were children, almost all of whom were diagnosed with a serious emotional disturbance.



Regional Management Plan

- Reviewed for compliance and approved by Iowa HHS.
- Policies and procedures manual for the regional service system
 Eligibility, enrollment, and service populations

- Annual service and budget plan

 Services provided; persons served; status of service development

Eligibility for Services – Adults

- Individuals who are age 18 and older
- Individuals with a diagnosis of mental illness (MI) or intellectual disability (ID)
 - May also cover individuals with developmental disabilities (DD) or brain injury (BI) when funding is available
- Individuals whose income is 150% of federal poverty level or below
 - May cover individuals at 150% 250% of FPL on a sliding scale
- The results of a standardized functional assessment support the need for services

Eligibility for Children's Behavioral Health Services

- The individual is a child under 18 years of age
- Child's custodial parent is a resident of the state of Iowa, and the child is physically present in the state
- The child's family has countable household income equal to or less than 500 percent of the federal poverty level
 - Cost share on a sliding scale for 150%-500% FPL.
- The child has been diagnosed with a serious emotional disturbance (SED)
- SED diagnosis is not required to access crisis services
- A 17-yr old receiving publicly funded ID services is eligible for regional funding for the three-month period preceding their eighteenth birthday in order to provide a smooth transition from children's to adult services
