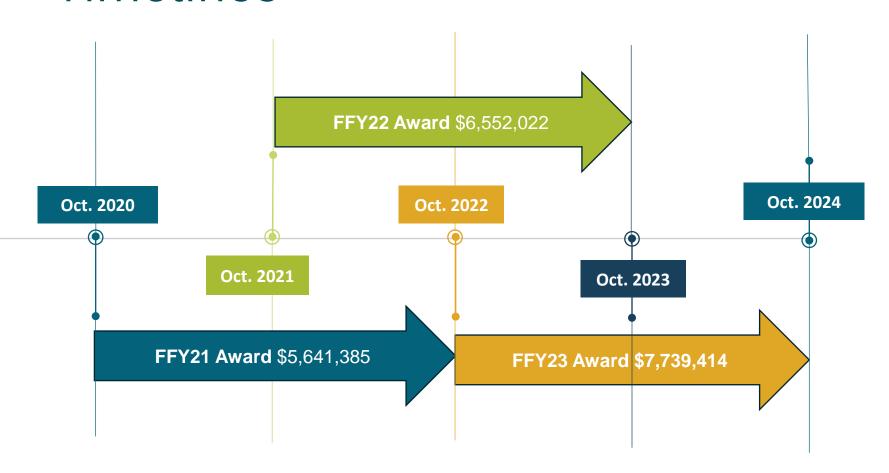
Community Mental Health Block Grant

- Awarded by the Substance Abuse and Mental Health Services Administration (SAMHSA)
- ► Funds are used to provide comprehensive community-based mental health services to adults with serious mental illnesses and to children with serious emotional disturbances.
