Children's Mental Health Waiver



Childrens Mental Health Waiver

Changes became effective October 1, 2024

- ► Eligibility
- Children residing with a Foster Family are eligible to apply and receive CMHW services.
- ▶ Waiver Priority Needs Assessment (WPNA)
- Children with urgent or emergent need for waiver services
- Parent or IHH may submit the WPNA for consideration of waitlist prioritization
- ► Reserved Capacity Slots
- Added QRTP as a setting where a member may be receiving services and request a Reserved Capacity Slot





New Service: Medical Day Care for Children

- Children with complex medical or behavior needs
- Child has exceptional care needs that can not be met in a traditional childcare setting.
- State Plan Child Care Medical services are not available
- Delivered in the child's home and community while the parents are working
- Requires statement of medical necessity from the child's primary care physician annually



New Service: Medical Day Care for Children

- Child must first access all State Plan services for which they are eligible.
- Does not replace the parent's financial responsibility for their child's care.
- Does not occur during hours when the child is attending school.
- Does not occur at the same time as other service provision such as respite, private duty nursing and personal care.

State Plan HCBS Habilitation

SPA changes become effective retroactively November 1, 2024, upon CMS approval

Home Based Habilitation (HBH) service delivery models added:

- ► HBH delivered in a **Host Home**
- ► HBH delivered via Remote Support
- ► HBH delivered via **Telehealth**



New Service: Enabling Technology for Remote Support

"Enabling technology" means the technology that makes the on demand remote supervision and support possible and includes a device, product system, or engineered solution whether acquired commercially, modified, or customized that addresses an individual's needs and outcomes Identified in his or her individual service plan.





New Service: Enabling Technology for Remote Support

- ➤ Assessment Enabling Technology Screening Tool
 - ➤ Completed by the HBH Agency Provider with the participation of member, member's guardian or legal representative and the Care Coordinator.
 - ➤ Identifies the member's interest, readiness and need for Enabling technology.

➤ Enabling Technology

- Technology that enables the delivery of HBH by a Remote Support Professional
- Smart appliances, detectors, monitors, sensors, cameras, displays, wearable GPS, tablets, laptops





PROPOSED FUTURE WAIVER DESIGN

Supporting families, serving individuals across the lifespan, and serving individuals in the living situation that works best for them and their families.

HOME WAIVER - CHILDREN & YOUTH

Service package that supports life domains in early childhood, in school and as youth transition into adulthood

02

HOME WAIVER - ADULT & AGING

Service package that supports life domains in adulthood and as lowans age

Each service package will address formal and informal support needs wherever lowans live.





ELIGIBILITY & ENROLLMENT | To be eligible, individuals must meet two criteria: **(I)** Fit into one of the qualifying disability categories **(2)** need institutional level of care
