

WIC i aa Telmi ka si bantu kin ka covo pawl:

- WIC i itelnak caah phung pawl cu miphun, cuar rong, chuahsemnak ram, kum, pum tlamtlinlonak asiloah nu le pa sinak ah thleidan lo tein aa khatmi a si.
- Mah WIC tinhmi cu a-ha-ra, hnuak peknak le a ngandammi rawl pawl konglam pek ii ka herhmi a dang ngandmanak asilolah mibu rianttuanpiaknak he ipeh tein a kan chiahnak hnga a si. Hi rianttuanpiaknak pawl ahhin itel dingah forh ka si.
- WIC ngandamnak lei a thiam ngaimi pawl cu keimah he a-ha-ra kong timhmi ah huncho khawhnak hnga ngan a dammi umtuning a kan ser tuah lai.
- Ramkulh dang ah i thial ka itimh ahcun, WIC sin ah ka chim laii i thialnak cahren pawl a kan pek lai, mah cun WIC rianttuanpiaknak pawl ka ngah peh kho lai.
- WIC rianttuantu nih WIC ah ka itel kho lo tiah a kan chimh ii ka hna a tla lo ahcun, a Hmaanmi Ngaihnak caah ka hal khawh. Ka itlaknak kong ca ka hmuh ni in kan pawngkam ii WIC zung sin ah ca kuat dingah silole pehtlai dingah le pakhatkhat hal dingah ni 60 ka ngei.

WIC i aa Telmi ka si bantu kin ka Tuanvo pawl:

- WIC Program pakhat nakin a tam deuh ah itelnak cu upadi ningin a si lomi a si ii cu caah program sin in donghternak a hung can lai.
- Ka chungkhar ii WIC soktu dihlak caah WIC ngandamnak chekhlainak cu ka onhpiak. WIC ngandamnak chekhlainak ahcun ngandamnak le rawl he aa pehtlaimi biahalnak pawl lehnak, sannak le rihnak tahnak le thider zawtnak caah thi chekhlainak pawl an itel. Ka chungkhar herhmi ca tthatnemnak pawl a kan pek dingah mah nihhin WIC khaa ibawmh.

- WIC rianttuantu chungtel pawl, eidin awk thil zuarnak chawdawr rianttuantu pawl, le inn pawl cu ziaza dawh tein le upanakin kan pehtlai lai. Keimah, asiloah ka aiawhtu pawl nih WIC rianttuantu asiloah eidin awk thil zuarnak chawdawr i rianttuantu pakhatkhat kha kaa chimmi bia in ningcang loin hmanna, tuaitamnak, hrocernak asiloah takpum leiin hrawhnak peknak caah ka WIC rawl tthatnemnak pawl ka/kan thlau khawh ti ka hngalhthiam.
- Ka WIC rawl tthatnemnak cazin ii a iteli hnatlakpimi rawl pawl lawng kha eWIC card a kan pekmi he ka cawk lai.
- Program ii a ummi pumpak(pawl) caah WIC rawl pawl lawng ka hman lai. Mah WIC rawl pawl hi pumpak a-ha-rah he aa pehtlaimi tthatnak bawmh dingah le kaiter dingah pek a si ii a biapimi thazang a pe khomi pawl asiloah rawl pawl ei awkah fimchimhmi ka phanhnak caah bawmhna ding a si ti ka hngalhthiam.
- An ka pekmi ze i rawl/formula silole tthatnemnak pawl hmanh hi chawleh dingah, ttial dingah silole thlen dingah, asiloah zuar i timh dingah, zuar dingah izuamhnak, ttial dingah asiloah thlen dingah ka hman lai lo. Aho hmanh ka pekmi ze i rawl/formula silole tthatnemnak pawl hmanh hi chawleh dingah, zuar dingah ttial dingah, silole chawleh dingah, zuar dingah, asilolah thlen dingah h ka i onhpiak lai lo.
- Mah pawl hi zuar dingah, chawleh dingah ka itimh ahcun, WIC chuahmi he aa khatmi WIC fund silo mi he ka cawkmi rawl asiloah formula ca chawlehnak receipt pawl cu thla thum chung ttha tein ka chiah lai. Mah hi ka WIC fund pawl he ka cawkmi an si lo tiah ka langhter khonak caah a si.

WIC i aa Telmi ka si bantukin ka hngalhthiam:

- Tthohkhannak caan donghnak ah ka sok tthan a herh ii program i aa tlakmi sinak caah zohthhan ka si lai.
- WIC nih cumi thla ca herhmi rawl asiloah formula dihlak kha a pek lo, a ruang cu WIC cu a chapmi program a si caah a si.
- Aa peh thliahmahmi thla li chungah rawl tthatnemnak pawl ka hmu lo a si ahcun, program in donghter ka si lai.
- Department of Health and Human Services (HHS) nih ka WIC konglam kha ngandamnak le cawnnak program pawl he hrawm khawhnak a pek men lai. Hi program pawl nih hin anmah program pawl caah ka i tlaknak pawl biakhiah dingah; hi konglam hi a hmang kho; mah cu program pawl konglam a kan pek ii soknak rian kha fawiter dingah; anmah program pawl ah ka min a um cang ahcun ka ngandamnak, cawnnak asilole tthatnak pawl tthanchoter dingah asiloah; cun ka ngandamnak lei zohkhnehnak herhmi pawl phak dingah mah konglam hi a hmang kho. Mah konglam hi WIC agency pawl le cozah bu nih WIC Program ca ii aa tlakmi pumpak pawl rianttuanpiaknak caah a hmang lai. HHS nih federal silole ramkulh upadi ningzuhl in asiloah onhnak in mah ka WIC konglam hrawmnak hi nawl a pek kho ti ka hngalhthiam. WIC pawlisi "Aa Telmi Konglam Thlithup" i hmuh a si bntukin ka WIC konglam hrawm khomi HHS program pawl cazin pakhat ka hal khawh.
