

### **WIC Sungtel sinak ih Ka Covo Pawl**

- WIC ih dan pawl cu miphun, taksa rawng, suahkehnak ram, kum, rualbanlo asilole mipa nunau zate hrangah a bangran theh.
- WIC ih tumtahmi cu thazang cahnak, nau hnawi fawh le harhdamnak ei in thuhla theihternak le ka tul dingmi pawlkom cangvaihnak le harhdamnak dang pawl thawi pehtlaihawkknak tuah sak a si. Hi tuahsaknak pawl ih tel dingin thapek ka si.
- WIC harhdamnak mithiam pawl in keimah thawn tangtlang in a harhdammi nun dan ngah thei dingah in bawm ding.
- State dangih ka thawn awk asilen, WIC hnenah ka sim dingih, cule thawnawknak ca in ken dingih cutikah ka WIC ka peh sal thei ding.
- WIC ah ka tel thei lo tin WIC hnatuantu in i sim tikah, ka lungkim lo asilen, Dikzetih Thuhla Ngainak ka dil thei. Ka tlinnak ca ka dawng hnu ah ka tualsung WIC zung ih cakuat dingah asilole ko ding ah dilnak tuah dingin ni 60 ka nei.

### **WIC sungtel pakhat dinhmun ih Ka Tuanvo Pawl:**

- WIC eiin pawl cu program ih tel (pawl) hrang lawngah ka hmang ding. WIC eiin pawl cu minung harhdam ih thazang cahnak an bawm ih, a thupi mi eiin asilole thazang hrang atha dingmi a hril bawm.
