Introduction

Heart of Iowa MHDS Region was formed under Iowa Code Chapter 28E to create a Mental Health and Disability Service Region in compliance with Iowa Code 331.390. The annual report is a component of the Management Plan which includes three parts: Annual Service and Budget Plan, Annual Report and Policies and Procedures Manual in compliance with Iowa Administrative Code 441.25.

The FY2022 Annual Report covers the period of July 1, 2021 to June 30, 2022. The annual report includes documentation of the status of service development, services actually provided, individuals served, designated intensive mental health services, a financial statement including revenues, expenditures and levies and specific regional outcomes for the year.

- Be licensed as a substance abuse treatment program or have a written cooperative agreement.
- Accept and service eligible individuals who are court-ordered.
- Provide services to eligible individuals on a no reject, no eject basis.
- Serve no more than five individuals at a site.
- Be located in a neighborhood setting to maximize community integration and natural supports.
- Demonstrate specialization in serving individuals with an SPMI or multi-occurring conditions and serve individuals with similar conditions in the same site.

D. Status of Service Development in FY2022

In the fall of 2021, HICS applied for Innovator Status for Audubon and Guthrie Counties under the NaCo Stepping Up initiative, essentially making the entire region an Innovator Region. Guthrie accepted the statue but Audubon has been hesitant. Our partners with Stepping Up have been assisting with providing information throughout 2022 and we are hopeful Audubon will sign on.

In FY22, HICS began its Co-Responder and CIT program. Five departments agreed to participate in the development of one co-responder team per department. The co-responder team consists of one dedicated Crisis Intervention Officer and a mental health profession partnered on a shift. They respond to mental health calls they are directly dispatched to and also intervene when other officers encounter someone in mental health crisis. The CIT team is able to follow up on calls received by officers when they are not on. We had one team ready to go July 1 with a cost of approximately \$250,000. Other teams will roll out over FY23.

This team will apply principles of pre-booking jail diversion which will keep individuals will mental illness from reaching jail when they commit low level offenses and zero intercepts are applied. With proper interventions put in place, individuals can be put into services and avoid jail altogether.

Along with this project, 85% of the law enforcement agencies in the Heart of Iowa Region agreed to be 100% CIT trained. This started in March of 2022 with FY22 cost around \$120,000. Additional costs will apply in FY23 as the contract continues. HICS is partnering with Solution Point Plus for training and consultation.

HICS began to enhance therapy in the schools within the region in FY22. We are adding telehealth into rural schools while exploring access to more onsite therapist and also exploring virtual therapy.

HICS created a Child and Adolescent Program Navigator position to meet regularly with the schools throughout the region and work solely with children through adolescence. We have found this position has worked really well with wrapping services around the entire family. Oftentimes, we are offering therapy or other services to parents when issues arise with their children. While we recognize there are many families we begin working with that wrap around services may be the goal, the majority of our families come to us seeking only services for their children. Our Navigator is able to recognize and offer additional services to the family and relieve some of those stressors' families don't realize they are experiencing. Many times, this is at no additional cost to the region.

In 2022, a MOU was developed with Mary Greely sub-acute. This has been a wonderful addition to the HICS Region. We have already used it multiple times.

E. Outcomes/Regional Accomplishments in FY2022

This year HICS made changes in our county hospitals emergency departments and jails in regards our telehealth company. The major difference we have found is individuals are seen much quicker by our new company, Flowstate Health, and placement is found in 2 to 6 hours after medical clearance. This is a major improvement over what we were seeing previously. By making this change, we have found that areas of improvement we need to focus on are transportation and moving individuals over to the Access Center whenever possible.

HICS benefited greatly from the MHDS Regions contracting with Solution Point Plus for the CIT training at ILEA. We have found the training is much more consistent across the state. We are better able to understand the needs of Law Enforcement in regards to training and how to assist them in getting that training to them.

Marketing is still a big focus for the Heart of Iowa Region. The regional website and a social media presence has been a huge benefit in getting individuals and their families to us and assist in getting services to them.

HICS began to really focus on getting Law Enforcement Departments in the region to be trained in CIT in March of 2022. By the end of June, 80 officers were trained. By June of 2023 all departments will be trained. This goes along with the Co-responder model running efficiently.

In March 2022, talks with Fifth Judicial in Dallas and Guthrie Counties began around getting mental health/specialty courts started. The ground work began and momentum has been gaining. All three counties in the region have very strong jail alternative programs already with a focus of court involvement. The mental health court will allow for the individuals to see their sentences deferred if they complete mental health and SUD activities set out in their court documents.

Moving forward, with all the HICS has done so far, we feel it is important to continue to develop services that will benefit the citizens with the region. With the roll out of the co-responder teams and the critical nature of access to services, HICS will be looking to develop a children's access center, additional outpatient/urgent care for both children and adults in a campus style setting, more therapeutic services in schools for children and adolescents and therapy services in the community for both children and adults.
