#### Introduction

Rolling Hills Community Services (RHCS) provides coordination and financial support for mental health and disability services to individuals located in the ten-county geographical area including Buena Vista, Calhoun, Carroll, Cherokee, Crawford, Humboldt, Ida, Pocahontas, Sac and Woodbury counties.

Rolling Hills Community Services Region was formed under Iowa Code Chapter 28E to create a Mental Health and Disability Service Region in compliance with Iowa Code 225C.57. The annual report is a component of the Management Plan which includes three parts: Annual Service and Budget Plan, Annual Report and Policies and Procedures Manual in compliance with Iowa Administrative Code 441.25.

The Annual Report is due to the Department of Health and Human Services by December 1, 2023. The FY2023 Annual Report covers the period of July 1, 2022 to June 30, 2023.

This Annual Report will reflect the ninth official year of regionalization and the efforts of multiple entities and partners that have joined together to develop services that aim to serve individuals within integrated community-based settings. This report contains information on the availability of core services, additional core services, and the efforts and plans for expansion of services. Also reported are the statistical reports of individuals funded, expenditures, revenues and levy information. In the final section, information will be provided regarding the successful outcomes of our Regional Strategic Plan.

# **D. Status of Service Development in FY2023**

The Rolling Hills Region Advisory Board held nine meetings during FY'23 to identify strategies for development of the remainder of the core crisis services needed to come into compliance with IAC Chapter 25. The services that were discussed are the Access Center, Subacute Services, Community Based Crisis Stabilization and Intensive Residential Service Homes. As a result of these meetings, Trivium opened the Region's first IRSH home in Sioux City in the fall of 2022. Siouxland Mental Health Center opened the Region's first Access Center in Sioux City in August of 2022 that offered Subacute as well as Community Based Crisis Stabilization and Crisis Stabilization Residential Based.

# E. Outcomes/Regional Accomplishments in FY2023

This section of the Annual Report contains multiple outcomes that have been achieved in alignment with our Region's vision and core service requirements.

Many stakeholders across the region have attended multiple meetings, focus groups and advisory meetings during year six to move our region in the direction of community-based service provision and development of additional services. Mobile Crisis was implemented in November of 2019 with more statistics to follow later in this report. Implementation of IRSH will be contingent on availability of funding and qualified staff to deliver high quality services. We have continued the process of collaborating with neighboring regions to identify priority services and make decisions based on provider and individual input as well as assessment of our region's needs.

#### STEPPING STONES TRANSITIONAL SERVICES

#### Report provided by Wesco Stepping Stones

#### **Admission Data:**

Stepping Stones admitted 19 individuals during Fiscal Year 2022-2023. At the end of the fiscal year, 6 individuals remained in the program.

Obtaining Social Security for individuals continues to be a barrier for them when it comes to individuals being able to move on from Stepping Stones. Without a means of sustainable income, the individuals stay in the program for longer periods of time than is ideal. Medicaid has recently become an additional barrier as it is taking longer for individuals to get Medicaid for IHH and Habilitation Service purposes.

#### **Discharge Data:**

From the 19 individuals admitted in the fiscal year, 16 were discharged from the Stepping Stones program. 13 of the 16 individuals were discharged successfully which means that they had services and skills in place to maintain independence upon discharge. Within those that were discharged from the program, 8 continued on with Wesco services including 6 who went into housing and 2 that received SCL services. Of those successfully discharged from Stepping Stones, 3 went to other providers, 2 left to live on their own with no services.

3 individuals were unsuccessfully discharged during the fiscal year with one leaving to live with a friend, one was arrested for failing to comply with a court order and another and 2 left to live with a friend. These individuals were considered unsuccessful as they did not leave with crucial services or skills including no employment and no means to support themselves independently.

#### **Referrals:**

For a few months at the end of 2022-beginning of 2023, Stepping Stones held all intakes and referrals due to the uncertainties surrounding the funding of Stepping Stones. This has affected the amount of people that we were able to serve, and consequently the bed days as well. We continue to be blessed to be able to serve the individuals needing assistance in the region. As in previous years, there is a lot to celebrate! Stepping Stones staff continues to receive information and trainings on how to effectively work with individuals who have struggled with their mental health and substance use in the past.

A few of their Success Stories from the past year:

We received an individual into our services that was very secluded throughout her life with her parents being her only supports. When both of her parents passed away she was forced to try to figure out life on her own. While at Stepping Stones we were able to assist her in getting all of her official documents, get habilitation services after several attempts at med exemption, and she was able to move into a hab home. She is now making friends and thriving in her living environment.

Another individual that we were able to work with had a long history of drug use and had recently been in legal trouble. She came to us, was able to get a job and moved into her own apartment to receive SCL services. While she was with us she was able to obtain skills she would need in order to maintain her sobriety and live independently. She was also able to get the support she needed to stand up to a man that had taken advantage of, manipulated and abused her over the last several years.

The staff at Stepping Stones continue to work on skill building when it comes to the individuals obtaining and maintaining independence. We are working towards expanding the information obtained through the

programming workbooks and adding in volunteer work and other activities to expand the experience that they get while at Stepping Stones. – Source Stepping Stones Transitional Living Administrator Tara Trieweiler

Rolling Hills also provided block grant dollars in the amount of \$214,131 to Siouxland Mental Health Center to offer Drop-In Center services at the Friendship House in Sioux City.

The Drop-in Center located in Carroll is the Clubhouse. There were a total of 1,370 client visits from July of 2022-June of 2023. The average was 115.6 per month. There were 17 new members.

The Den ran July 2022-Jan 2023. There were 237 client visits with a monthly average of 33.85.

### **TELEHEALTH SERVICES**

In October 2017, the Rolling Hills Region contracted with Integrated Telehealth Partners (ITP) to provide psychiatric evaluations within our Emergency Departments and Jails. Data provided by ITP for Fiscal Year 2023 is included as an attachment to this report.

### JAIL DIVERSION DATA / JUSTICE SYSTEM INVOLVED SERVICES

The Coordinators of Disability Services have been providing Justice Involved Service Coordination since the Region formed in 2014. They work regularly with Jail staff, Attorneys and providers to assist individuals with obtaining access to mental health services and also to assist with the transition back into the community.

Even though people may be going to prison because of their charges, some will want to have regular visits for support/counseling, especially younger individuals and those having never been to prison.

Providing resources includes information of MH/SA evaluation/treatment facilities, helping the jail staff get meds, providing general assistance after they leave jail, Medicaid applications, disability applications, housing assistance and food stamp applications. Often the individuals that leave the jail before being seen are given jail services coordinators contact info to assist them when they leave jail.

There is a great need for placement of individuals after they leave jail in a supportive setting. Homeless shelters aren't always appropriate if the proper supports are not in place. We need to balance that with the individual who may have an aggressive/assaultive history or who are sexual perpetrators and finding placement is almost impossible.

Many of the individuals who want to see a Coordinator in jail tend to need someone to talk to. This has helped the jail work through some behavior concerns while the person is waiting for competency evaluation or sentencing.




# Telepsych Services - Jail Rolling Hills MHDS Region July 2022- June 2023

% of Appointments by Type









# % of Cases by Involuntary Status




