I. Minutes

Motion made by Ms. Rozeboom and seconded by Ms. McGrath to approve the May 9, 2024 minutes as written. Motion carried unanimously.

II. Substance Use Disorder/Problem Gambling Licensure

A. Licensure Recommendations

1) 270 Day License:

Motion made by Ms. Rozeboom and seconded by Ms. McGrath to approve a license for a period of 270 days to the following programs:

- a. **Mid Iowa Behavioral Services, West Des Moines, Iowa**, license effective **June 13, 2024 to March 10, 2025**.
- b. **Axial Clinic IA, P.C. D/B/A Wayspring Clinic, Des Moines, Iowa**, license effective **June 13, 2024 to March 10, 2025**.

2) One (1) Year License:

- b. **The Robert Young Center for Community Mental Health, Muscatine, Iowa**, based on the accreditation survey conducted and accreditation awarded by Council on Accreditation of Rehabilitation Facilities, license effective **May 26, 2024 to November 30, 2025.**
