## Fourteenth Amendment to the Member Management, Consumer Assistance, and Eligibility Help Desk Services for Iowa Medicaid and Hawki Programs Contract

This Amendment to Contract Number MED-19-012 is effective as of January 1, 2024, between the Iowa Department of Human Services (Agency) and MAXIMUS Health Services, Inc. (Contractor).

### **Section 1: Amendment to Contract Language**

The Contract is amended as follows:

# Revision 1. Section 1.5.2 entitled "Payment Methodology" is amended to add the following at the end of the section:

For the period of January 1, 2024 through June 30, 2024, in addition to the base payment obligations of the Contract, the Agency agrees to pay the Contractor to continue providing 33 CSRs, 2 Supervisors, and 1 Lead worker. These additional staff will be responsible, not only for continued PHE Unwind activities, but also for an increase of incoming calls related to the dental provider changes taking place in 2024. It is anticipated the incoming calls for PHE Unwind will slow in April at which time dental provider assignment notices will be sent to Members, which will result in increased calls related to these notices. The Contractor shall work to shift CSRs as needed to answer the dental assignment change inquiries. The Contractor is responsible to manage the flex in staff to meet all current required service levels.
