

**Fifteenth Amendment to the Member Management, Consumer Assistance, and Eligibility Help Desk Services for Iowa Medicaid and Hawki Programs Contract**

This Amendment to Contract Number MED-19-012 is effective as of July 1, 2024, between the Iowa Department of Human Services (Agency) and MAXIMUS US Services, Inc. (Contractor).

**Section 1: Amendment to Contract Language**

The Contract is amended as follows:

**Revision 1. Contract Duration.** The Contract is hereby extended from July 1, 2024, through December 31, 2024.

**Revision 2. Section 1.5, Pricing.** The maximum amount the Contractor will be compensated is hereby amended to \$21,466,627.10 for the entire term of the Contract. Attachment 3.1: Pricing Schedule is amended to add 6 months of baseline services at \$247,658.91 a month (see attachment).

**Revision 3. Section 1.5, Payment Table.** Contract payments are amended to add the following:
