COMES NOW the Iowa Department of Public Health (“Department”) and Travis L. Hurley (“Appellant”), and pursuant to Iowa Code sections 17A.10 and 641 Iowa Administrative Code 131.12(7), enter into the following settlement of this matter:

1. On May 4, 2018, the Department issued a Notice of Proposed Action: Revocation, directed to Appellant.
2. On May 18, 2018, Appellant requested a hearing regarding the proposed probation.
3. The Department of Inspections and Appeals has scheduled a contested case hearing on June 25, 2018.
4. On May 10, 2018 Appellant provided three probation reports covering the time periods of January 1, 2017 through March 31, 2017, October 1, 2017 through December 31, 2017 and January 1, 2018 through April 1, 2018.
5. Appellant hereby withdraws his request for appeal in the above-captioned matter. Execution of this Consent Agreement by all parties constitutes the resolution of this contested case. Appellant waives the right to hearing and all attendant rights, including the right to appeal, by freely and voluntarily agreeing to this Consent Agreement.

6. This consent agreement is subject to approval of the Department. If the Department approves this agreement, it becomes the final disposition in this matter. If the Department fails to approve this agreement, it shall be of no force or effect to either party.

7. This Consent Agreement shall be part of the permanent record of the Appellant and may be considered by the Department in determining the nature and severity of any disciplinary action to be imposed in the event of any future violations.

8. This Consent Agreement and the Notice of Proposed Action are public records available for inspection and copying in accordance with the requirements of Iowa Code chapter 22 and 272C.

9. The Department's approval of this Consent Agreement shall constitute a FINAL ORDER of the Department and constitutes final agency action in this matter.

IT IS THEREFORE ORDERED:


10. The Department rescinds the Notice of Proposed Action: Revocation issued on May 4, 2018.


11. Appellant agrees to make a personal appearance before the Department upon request no later than July 10, 2018, October 10, 2018, January 10, 2019 and April 10, 2019. Appellant will be given reasonable notice of the date, time and place of appearance.

12. Appellant agrees to submit a specimen of blood or urine to a Department investigator or designee no later than July 10, 2018, October 10, 2018, January 10, 2019 and April 10, 2019. Appellant agrees to sign all necessary release of information forms to ensure the Department receives results from testing as soon as results are available. Appellant agrees to incur the costs of all such tests.

13. Appellant agrees to pay a civil penalty in the amount of \$300 prior to April 10, 2019. The civil penalty shall be made payable to the Treasures of Iowa and mailed to the Department. The civil penalty shall be deposited into the State General Fund.
