REVOCATION

Pursuant to the provisions of Iowa Code Sections 17A.18, 147A.7, and Iowa Administrative Code (I.A.C.) 641-131.7, the Iowa Department of Public Health is proposing to **Revoke** your EMS certification identified above.

The department may revoke an EMS certification when it finds that the applicant or certificate holder has committed any of the following acts or offenses:

Failure to comply with the terms of a department order or the terms of a settlement agreement or consent order. IAC 641-131.7(3)i

Willful or repeated violations of Iowa Code chapter 147A or these rules. IAC 641-131.7(3)s

The following has led to this notice:

On April 15, 2015 the Department issued you a notice of proposed action, probation (case # 15-04-01). This action became the Department's final action on May 5, 2015 and as a result your Iowa EMS certification was placed on probation from May 5, 2015 through May 5, 2019. As a condition of your probation, you are required to submit probation reports due on the tenth of April, July, October and January.

As of the date of this notice, you have failed to file the probation report due April 10, 2017 for the time period of January 1 through March 31, 2017. As of this date you have failed to file the probation report due October 10, 2017 for the time period of July 1 through September 30, 2017. As of the date of this notice you have failed to file the probation report due January 10, 2018 for the time period of October 1, 2017 through December 31, 2017. As of this date you have failed to file the probation report due April 10, 2018 for the time period of October 1, 2017 through December 31, 2017. As of this date you have failed to file the probation report due April 10, 2018 for the time period of January 1, 2018 through March 31, 2018.

Additionally, you filed four probation reports past due. The probation report due July 10, 2016 was received by the Department on July 14, 2016. The probation report due October 10, 2016 was received by the Department on October 24, 2016. The probation report due January 10, 2017 was received by the Department on February 6, 2017.

Previously, on February 1, 2016, the Department suspended your Iowa EMS certification and levied a civil penalty (case # 16-01-16) against you for failing to submit the probation report due January 10, 2016 for the time period of October 1 through December 31, 2015, which was later filed on February 8, 2016.

You have the right to request a hearing concerning this notice of disciplinary action. A request for a hearing must be submitted in writing to the Department by certified mail, return receipt requested, within twenty (20) days of receipt of this Notice of Proposed Action. The written request must be submitted to the Iowa Department of Public Health, Bureau of Emergency Medical Services, Lucas State Office Building, 321 E 12th St, Des Moines, Iowa 50319. If the request is made within the twenty (20) day time limit, the proposed action is suspended pending the outcome of the hearing. Prior to or at the hearing, the Department may rescind the notice upon satisfaction that the reason for the action has been or will be removed.

If no request for a hearing is received within the twenty (20) day time period, the disciplinary action proposed herein shall become effective and shall be final agency action.
