# MAAC and BAC Implementation: 2024

- ▶ A state team has been created to establish and implement changes to the BAC and the MAAC respectively.
- ▶ Changes to the requirements include:
  - Conduct outreach and provide education
  - Establish a member recruitment process
  - Determine how to meaningfully engage members
  - Identify topics that are priorities for members
  - Update the MAAC webpage and create a BAC webpage on the HHS website

July 9, 2025	<ul style="list-style-type: none"><li>▪ Revise MAAC and Establish BAC<ul style="list-style-type: none"><li>▪ New MAAC Board Selection Process</li></ul></li><li>▪ 10% of MAAC members should be from the BAC</li></ul>
July 9, 2026	<ul style="list-style-type: none"><li>▪ MAAC Annual Report</li><li>▪ 20% of MAAC members should be from the BAC</li></ul>
July 9, 2027	<ul style="list-style-type: none"><li>▪ MAAC Annual Report</li><li>▪ 25% of MAAC members should be from the BAC</li></ul>
