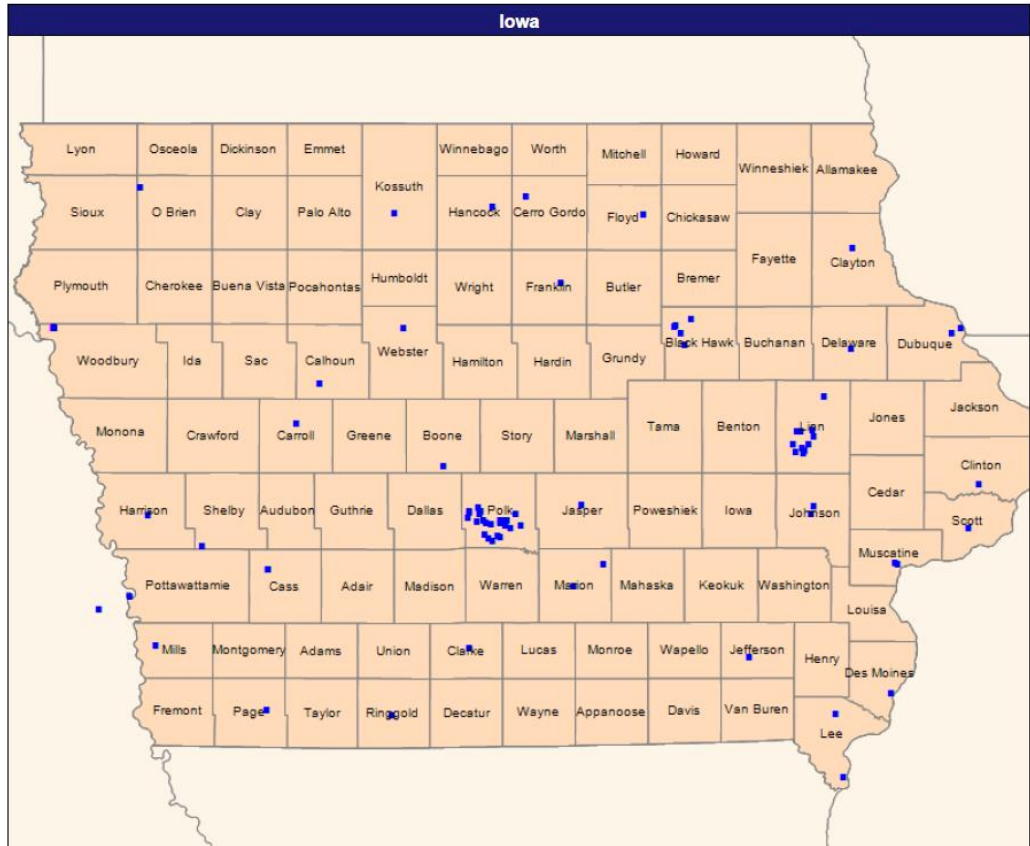


Table 1B Map: Waiver – Brain Injury – Prevocational Services – Urban - 30 minutes or miles: Less than 100% standard

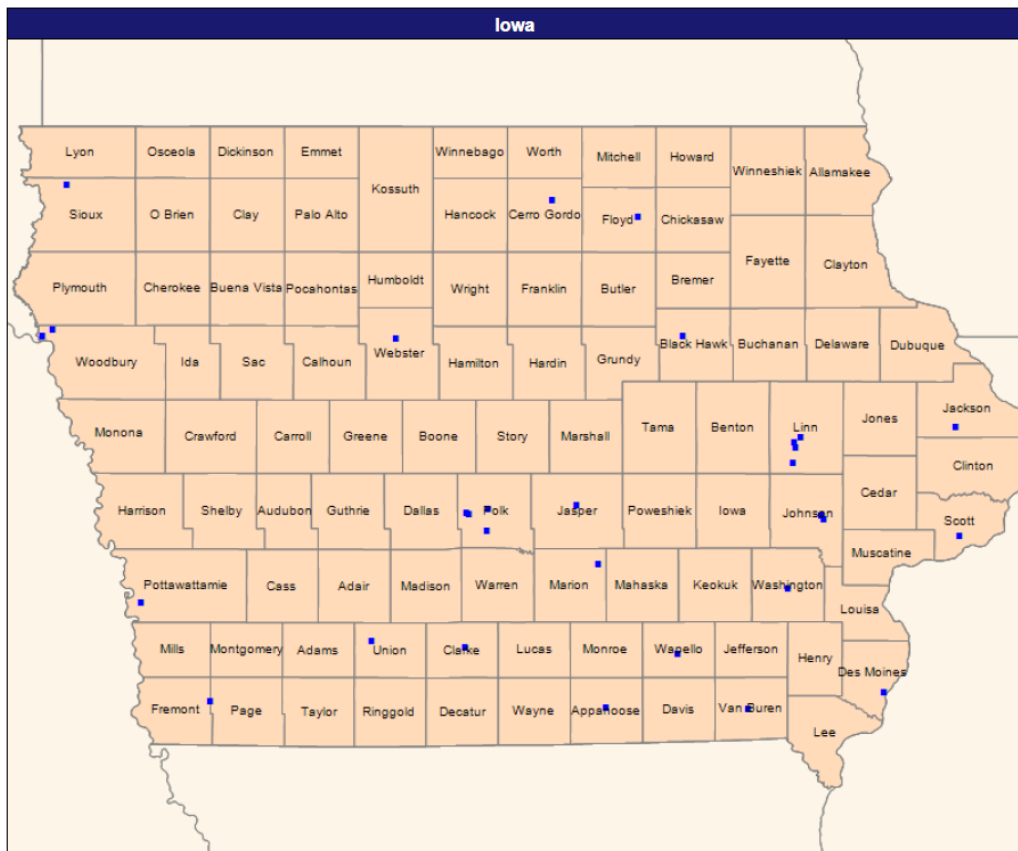


Table 1D Map: Waiver – Brain Injury – IMMT – Urban - 30 minutes or miles: Less than 100% standard

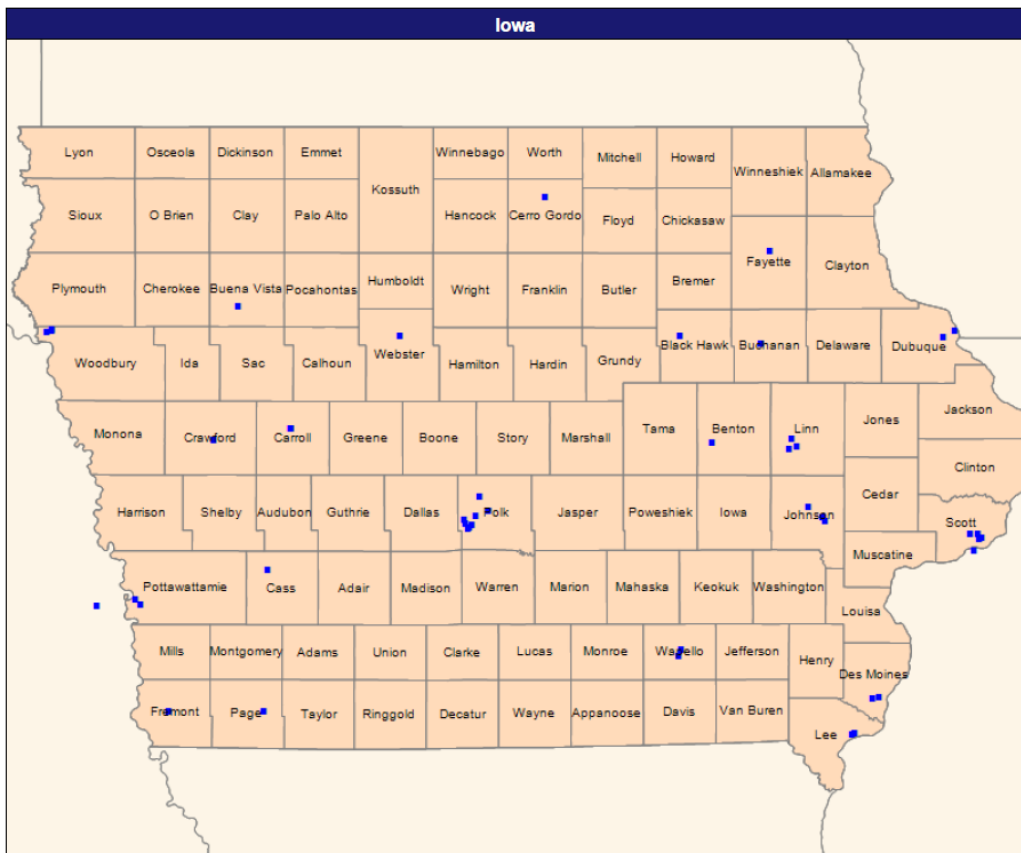


Table 1E Map: Waiver – Brain Injury – Respite – Urban - 30 minutes or miles: Less than 100% standard

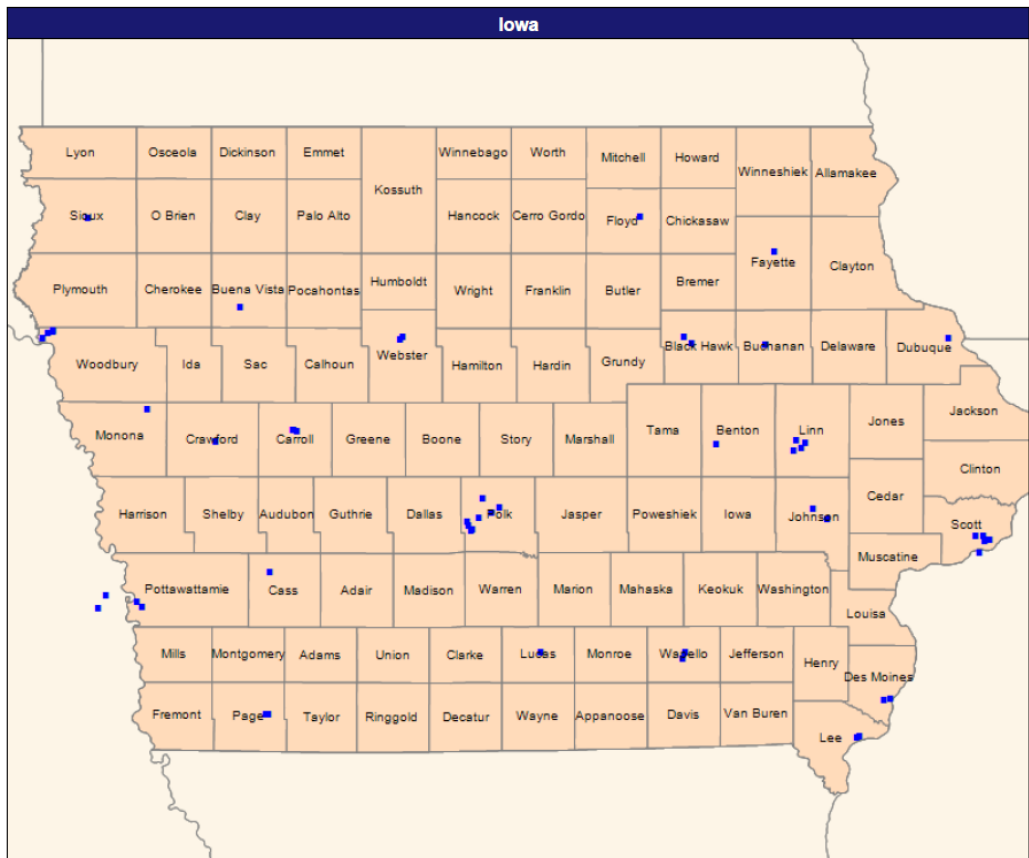


Table 1N Map: Waiver – Health & Disability – Respite – Urban - 30 minutes or miles: Less than 100% standard

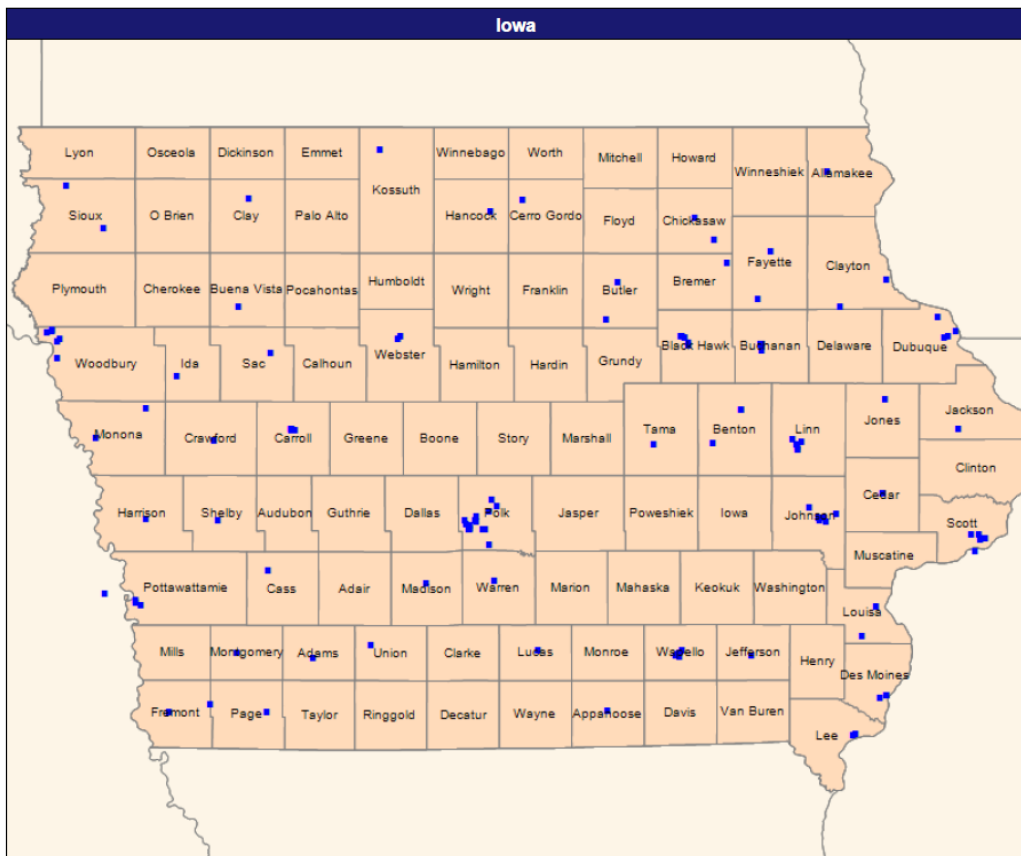


Table 10 Map: Waiver – Intellectual Disability – Prevocational Services – Urban - 30 minutes or miles: Less than 100% standard

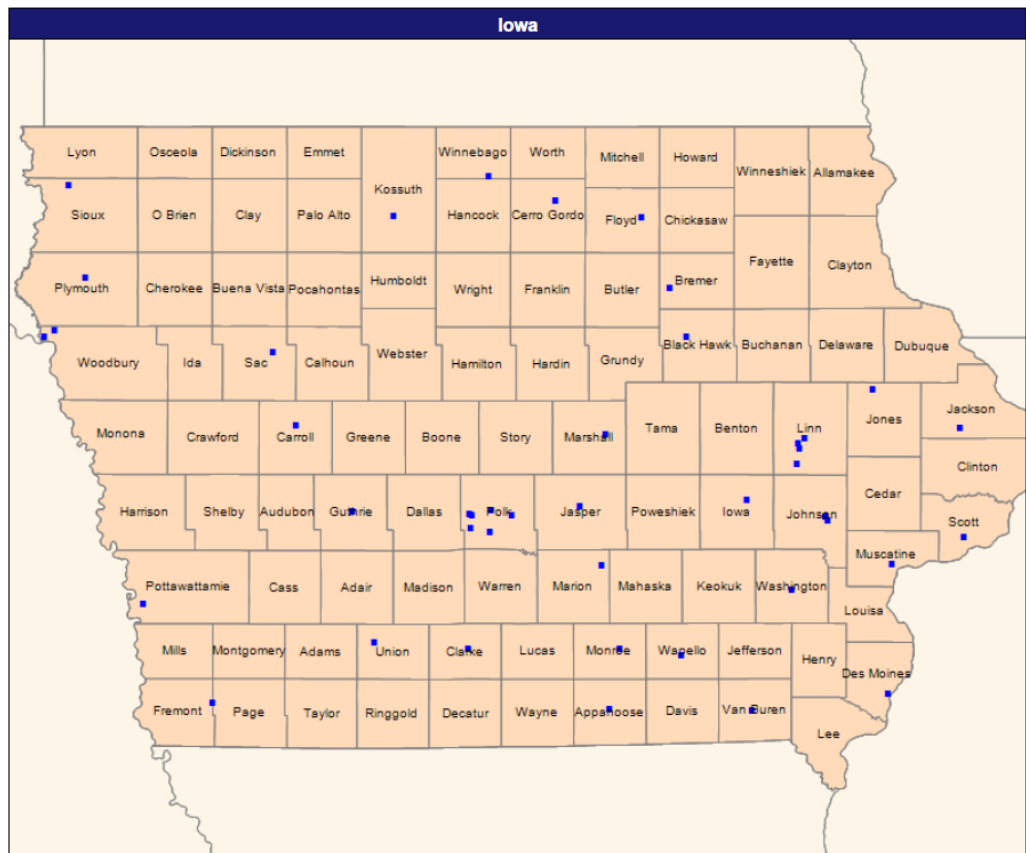


Table 1P Map: Waiver – Intellectual Disability – Prevocational Services – Rural - 60 minutes or miles: Less than 100% standard

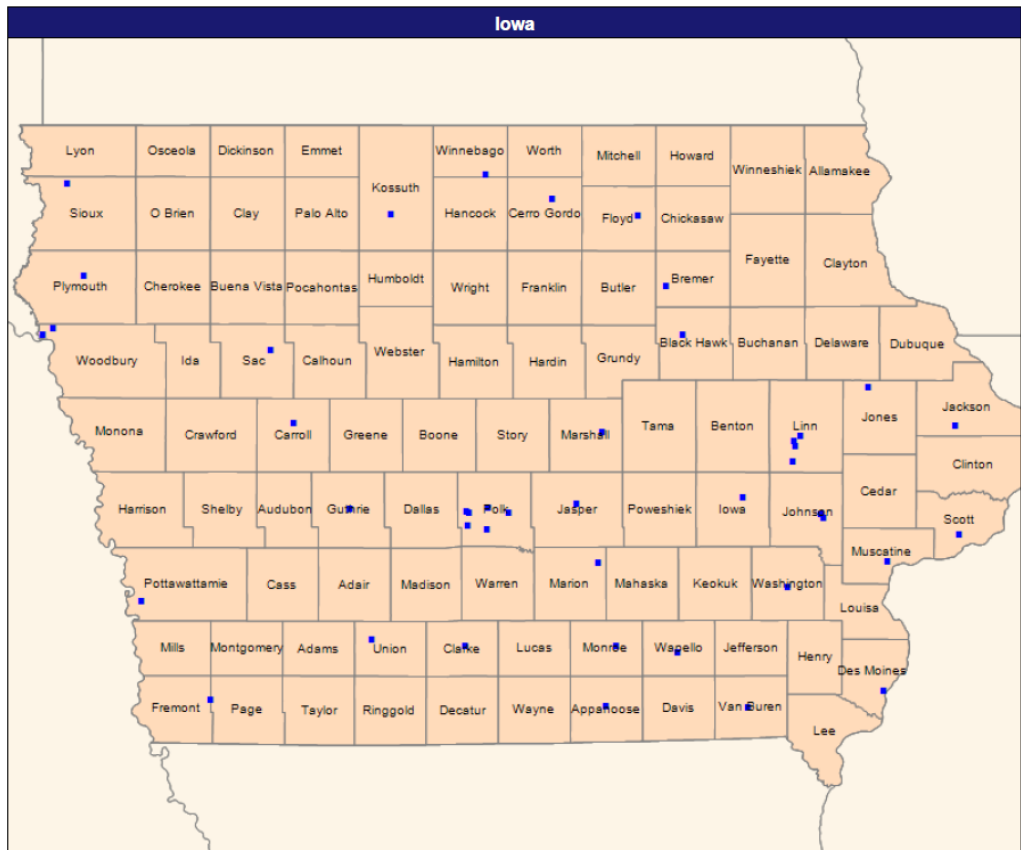


Table 1P Map: Waiver – Intellectual Disability – Supported Employment – Urban - 30 minutes or miles: Less than 100% standard
