On average, women drive 11 miles or 16 minutes to the nearest birthing hospital



33.3% of counties are defined as maternity care deserts compared to 32.6% percent in the U.S

Postpartum Expansion



- In 2024, Iowa extended Medicaid postpartum coverage from 2 months to 12 months for pregnant women.
- Pregnant Women 215% FPL or below
- Infants Under 1 302% FPL or below.

Begins on April 1, 2025.

Governor's Rural Health Initiatives 2025

- Invests \$642,000 into newly unbundled Medicaid maternal rates.
- Works with CMS to implement a funding model to stabilize labor and delivery units and incentivize regional partnerships between hospitals.
- Consolidates and more than double funding for our student loan repayment programs.
- Establishes a Medicaid Graduate Medical Education (GME) enhanced payment to draw down over \$150 million in federal dollars for more residency slots in Iowa's 14 teaching hospitals.
- Streamlines the approval process for certificates of need (CON).
- Improves the Health Information Exchange.

#### Mahaska Health

- 102% increase in births since 2021, with 267 babies born in 2024. We are on pace to deliver nearly 400 babies in FY 2025.
- Opened and expanded first ever fertility services, providing specialized care for 50 patients.
- Recruited two OB/GYN specialists, caring for 888 patients from 28 counties in 2024.



## Benefits to Iowa

The Centers of Excellence expand access to critical maternal health needs

### Alliance for Innovation on Maternal Health (AIM) Bundles

- Iowa enrolled in AIM in 2020 and deployed bundles in 2022.
  - Specialty bundles include hemorrhage, c-sections and hypertension
- Number of Iowa hospitals participating in AIM Bundles

  - 55/55 Hemorrhage
  - 43/56 C-sections

#### Statewide Perinatal Care Program

 Consultation with regional and primary providers, and evaluation of the quality of care delivered, aims to reduce the mortality and morbidity of infants.

 Technical assistance is provided individually to hospitals based on chart reviews during their site visits.



### University of Iowa Health Care Obstetrical Simulation Program



This program provided simulation-based education to over 600 lowa nurses, obstetrical providers, and emergency medicine providers.

Of Iowa's 35 Level I hospitals, 33 had a simulation training site visit.

- Delivery scenario includes recognition of a fetal nuchal cord, steps to reduce the nuchal cord, recognizing breeches and the appropriate steps to aid in the delivery of the placenta
- Participants learn immediate care of the new-born after delivery
- Hemorrhage scenario includes presentation and treatment of a patient with a postpartum hemorrhage & options available for postpartum hemorrhage.

### Healthy Pregnancy Program (HPP)

- Iowa's Healthy Pregnancy Program ensures early and adequate prenatal care for women by:
  - Assessing health insurance needs and assisting with Medicaid eligibility
  - Providing care coordination and appointment reminders
  - Offering transportation assistance
  - Educating on the importance of prenatal care
  - Promoting flu, Tdap, and COVID-19 vaccines
  - Funding Source Title V Block Grant, State Appropriations and Medicaid

# Iowa Perinatal Quality Care Collaborative

- Iowa's first Perinatal Quality Care Collaborative (IPQCC) was created in fall 2023 with the merging of the Iowa Neonatal Quality Collaborative (INQC) and the Iowa Maternal Quality Care Collaborative (IMQCC).
- The collaborative strengthens INQC capacity to focus on Quality Improvement Initiatives, builds upon Iowa's successful implementation of Iowa's AIM program through the IMQCC.

#### ► Focuses on:

- Quality improvements as a strategy
- Perinatal Quality Collaboratives (PQCs)
  - Supported by the National Network of PQC funded by CDC and managed by the National Institute of Children's Health Quality.
- Reducing incidence of hypoxic-ischemic encephalopathy (HIE)
