COMES NOW the Iowa Department of Public Health ("Department") and Chris Tool and Reasnor Fire Department ("Appellants"), and pursuant to Iowa Code section 17A.10 and 641 Iowa Administrative Code 131.12 enter into the following settlement of this matter:

1. On May 4, 2018, the Department issued a Notice of Proposed Action: Probation, directed to Appellant Reasnor Fire Department. On May 4, 2018, the Department issued a Notice of Proposed Action: Revocation, directed to Appellant Chris Tool.
2. On May 31, 2018, Appellants requested a hearing regarding the proposed actions.
3. The cases are currently scheduled for hearing July 5, 2018.

4. Appellants hereby withdraw their requests for appeal in the above-captioned matters. Execution of this Consent Agreement by all parties constitutes the resolution of these contested cases. Appellants waive the right to hearing and all attendant rights, including the right to appeal, by freely and voluntarily agreeing to this Consent Agreement.

5. This Consent Agreement is subject to approval of the Department. If the Department approves this Agreement, it becomes the final disposition of this matter. If the Department fails to approve this Agreement, it shall be of no force or effect to either party.

6. This Consent Agreement shall be part of the permanent record of Appellants and shall be considered by the Department in determining the nature and severity of any disciplinary action to be imposed in the event of any future violations.

7. This Consent Agreement and the Notices of Proposed Action are public records available for inspection and copying in accordance with the requirements of Iowa Code chapters 22 and 272C.

8. The Department's approval of this Consent Agreement shall constitute a FINAL ORDER of the Department and constitutes final agency action in these matters.

IT IS THEREFORE ORDERED:

9. The Notice of Proposed Action: Probation issued to Appellant Reasnor Fire Department becomes effective as of the date of execution of this Consent Agreement. Appellant Reasnor Fire Department's authorization shall be placed on PROBATION for a period of two years from the date of execution of this Consent Agreement subject to all terms and conditions contained in the Notice of Proposed Action.

10. The Notice of Proposed Action: Revocation issued to Appellant Chris Tool is modified as follows: In lieu of revocation, Appellant's EMS certification shall be placed on INDEFINITE SUSPENSION. Appellant's EMS certification shall not be reinstated until the Department receives, reviews, and approves the documentation of: (1) 24 hours of continuing education received for the renewal period of April 1, 2015, to March 31, 2017, including 12 hours designated as formal education; (2) current course completion card in cardiopulmonary resuscitation, AED, and obstructed airway procedures for all age groups according to recognized national standards. These hours shall not be utilized for any other renewal period. Appellant is responsible for all costs associated with this requirement.

11. During the entire period of suspension, Appellant Chris Tool agrees not to provide emergency medical care to patients.

12. All other language, terms, and conditions in the Notice of Proposed Actions remain intact and in full force and effect.

13. In the event Appellants violate or fail to comply with any of the terms of this Consent Agreement, the Department may initiate appropriate action to revoke or suspend Appellant's certification or authorization or to impose other appropriate discipline.
