

SUPTRS Fee Schedule

The Iowa Department of Health and Human Services has allocated a portion of the Substance Use Prevention, Treatment, and Recovery Services (SUPTRS) Block Grant to subsidize the cost of substance use disorder (SUD) assessment and treatment services. Designated SUD treatment providers, who have an existing infrastructure designed to meet the SUPTRS federal regulations, may utilize this fee schedule.
