Intensive In-Home and Community Therapeutic Services	<p>the subcommittee's role in defining and designing an intensive in-home and community-based therapeutic service delivery system in the Iowa context.</p> <ul style="list-style-type: none"><li>• Several participants discussed service provision for children who are incarcerated and continuity of care as children transition between settings. They noted the importance of the subcommittee considering provider rates and care pathways.</li><li>• Participants discussed the language being used to define intellectual and developmental disabilities in the lawsuit to support the careful determination of care pathways.</li><li>• Participants discussed the intended use of the assessment tools are to evaluate youth experience and overall function and not to provide a clinical diagnosis.</li><li>• Iowa HHS confirmed that this meeting's PowerPoint and agenda will be posted to the Iowa HHS website under "Iowa REACH."</li><li>• Participants discussed the classification of therapeutic services that involve family members as defined by the class action lawsuit to note the importance of distinguishing training from therapies.</li><li>• Participants discussed the settings for Intensive In-Home and Community Therapeutic Services (IHCTS) in the context of medical necessity and preauthorization for Medicaid services. Participants also asked for clarification about the language around timing for IHCTS.</li><li>• Participants requested clarification on the criteria for loss of Medicaid eligibility.</li><li>• Participants discussed the importance of the subcommittee considering provider qualifications and the process for enrolling in Medicaid.</li></ul>
