Early Childhood Iowa Desired Results

Iowa Code 256I.2(3)

To achieve the desired results, the initiative's primary focus shall be on the efforts of the state and communities to work together to improve the efficiency and effectiveness of early care, education, health, and human services provided to families with children from zero through age five.



Early Childhood Iowa State Board

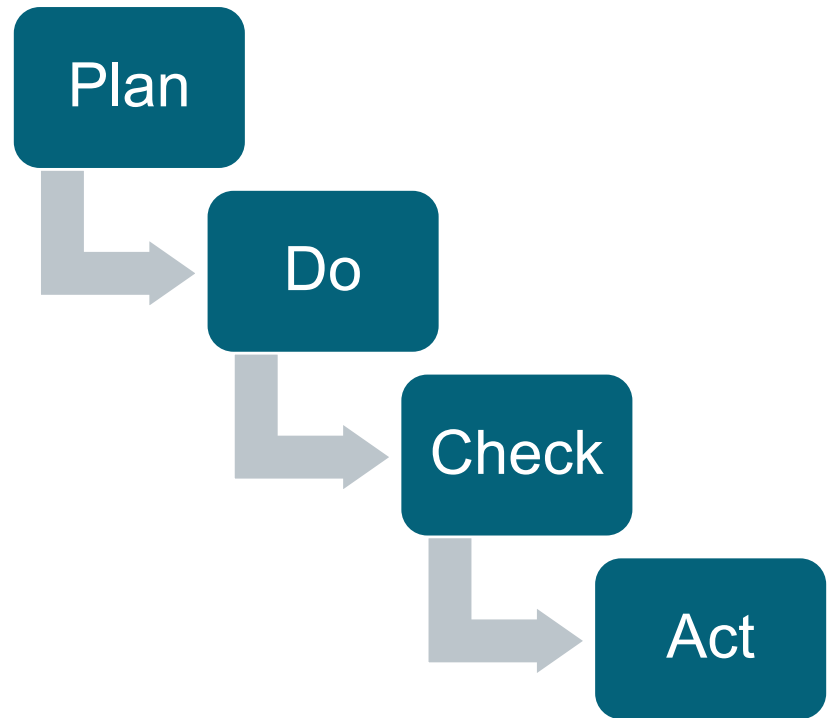
Iowa Code, 256I.3(1)

- ▶ The early childhood Iowa state board is created to promote a vision for a comprehensive early care, education, health, and human services system in this state. The board shall oversee state and local efforts.
- ▶ The vision shall be achieved through:
 - Strategic planning
 - Funding identification
 - Guidance
 - Decision-making authority to assure collaboration among state and local early care, education, health, and human services systems

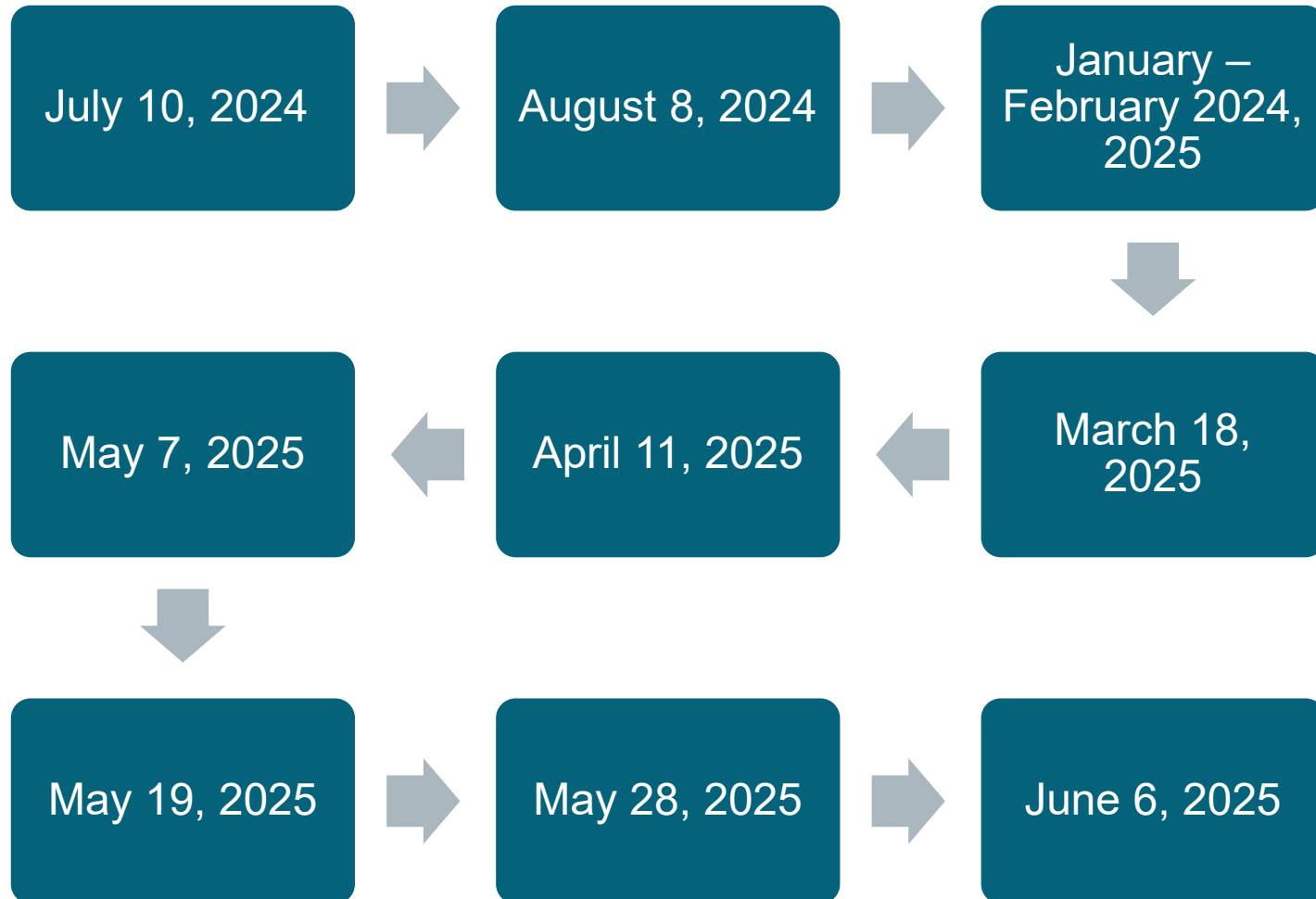

Common Performance Measures (Tool O)

- ▶ Iowa Code 256I.4(5), Adopt common performance measures and data reporting requirements, applicable statewide, for services, programs, and activities provided by area boards.
 - The data from common performance measures and other data shall be posted on the early childhood Iowa internet site and disseminated by other means and shall also be aggregated to provide statewide information.

Clarification

- ▶ Scholarships
 - Time beyond Statewide Voluntary Preschool (SWVPP) or other publicly funded preschool day
 - Locally determined rates for time beyond other funding sources
 - Head Start expansion
- ▶ Wage Enhancement
 - Strengthen program stability
 - Improve quality

Funding and Tool G

- ▶ Iowa Code 256I.4(4), manage and coordinate the provision of grant funding and other moneys made available to Early Childhood Iowa Areas by combining all or portions of appropriations or other revenues as authorized by law
- ▶ Iowa Code 256I.11(3), unless a different amount is authorize by law, up to 5% of the school ready children grant moneys distributed to an area board may be used by the area board for administrative costs

Family Support Timeline

May 21, 2025	Chapin Hall & ECI welcoming piloting programs
July - August 2025	Program data entry into DAISEY 2.0
July 2025 – January 2026	Ongoing TA with data pulls from ECI TA Team
February – June 2026	DAISEY 2.0 data pull options ready for local providers
July 1, 2026	All ECI state-funded family support home visitation programs utilize the pilot's enhanced procedural manual

Iowa Home Visiting 2.0 (IHV 2.0)

84% of programs signed up to participate in the pilot

Programs will participate in the following:

1. Follow the Home Visiting and Family Support Operations Manual
2. Identify family funder
3. Align program expectations with federal requirements (MIECHV Data Dictionary)
4. Provide feedback to State and DAISEY Teams
5. Engage in Continuous Quality Improvement efforts for family support programs
6. Technical assistance calls

Performance and Education Yield Success (PAEYS) for Family Support

- ▶ Increasing compensation based on educational attainment and quality performance as indicated with data fidelity entered into DAISEY
- ▶ Starting as a quality enhancement incentive
 - Workforce Data Updated in DAISEY
 - Assessments and Demographics completed on time
- ▶ Partnering with IowaAEYC
 - The more educated someone is, the higher their incentive
 - Role related degrees are eligible
 - Plan to continue to grow PAEYS
