Administrative Rule 441.109 Changes-Licensed Centers

Engaged with CCR&R, Iowa Afterschool Alliance, HHS team members, and child care facility directors

Applies to licensed child care centers only

Provides clarification and reduces complicated language

Removes contradictory and duplicative regulations

Primary Changes to 441.109

16 and 17-year-old staff are able to provide supervision:

- During structured nap hours for children aged 2-5
- For brief periods of absence, not to exceed 5 minutes

HHS licensing consultants have flexibility to approve combinations of children outside of what is regulated if appropriate and can ensure needs of the children are met, in unique circumstances

Provides clarification for centers that serve school aged children in school buildings and explains exceptions that apply to this space

HF390 Child Care Provider Physical Examinations

No longer has to be
"pre-employment"

Physical within 6
months after hire or
start date

Delayed physicals risk
being out of compliance

Child Care Providers:

- Have frequent contact with children (infant through school-age) in care.
- Are responsible for children's physical care and social development day or/and nighttime hours.
- May need to lift children, bend, and stand for long periods of time.

Immunization Status:

All child care employees and providers shall consult with their physician regarding the receipt of age appropriate immunizations in accordance with the current Advisory Committee on Immunization Practices (ACIP) recommended immunization schedule. Individuals involved in the provision of child care often come in contact with very young children, whom may or may not be fully immunized against vaccine-preventable diseases. It is essential every child care employee and provider discuss with their physician the benefits and risks associated with receiving or not receiving all ACIP age appropriate immunizations before becoming involved in a child care setting.

(Physician Must Check One)

- ☐ Patient's immunization history was reviewed and patient is current with all ACIP recommended immunizations.
- ☐ Patient received consultation regarding the receipt of age appropriate immunizations in accordance with the current ACIP recommended immunization schedule and declined the following recommended vaccinations:

Tuberculosis Screening:

All child care staff/providers are required to receive a baseline screening for Tuberculosis. Baseline screening shall consist of two components:

1. Assessing for current symptoms of active TB disease.
2. Screening for risk factors associated with TB.

NOTE: ONLY perform a TST or IGRA if the patient has an identified risk factor and/or current symptoms of TB disease. Do not test individuals with previous past positive test results.

Immunization Exemptions

Adds language in Iowa Code for Child Care Facilities (237A.3C)

Child Care Facilities shall include information regarding exemptions in any communication related to immunizations.

Changes

- ▶ Complete re-write

New Annual Inspection Report Templates for home and center-based providers will be used after July 1, 2025

All report templates will look the same across program types

Reports will also have the option to add “addendums” if further information is obtained

Professional Development (PD)

- ▶ Starting July 1, 2025
- ▶ Coaching PD hours can be provided by PD organizations that are contracted by HHS to provide coaching:
 - CCR&R
 - Child Care Nurse Consultants
 - Child Care Collaborative of Iowa's financial management coaches
 - First Children's Finance
- ▶ Coaching hours can only be used to fulfill half of regulatory or IQ4K PD hours requirements
- ▶ Removes 5-year limit from earning professional development hours for training
- ▶ Updated Professional Development Organization Approval Process

Child Care Assistance Applications

CCA Family Eligibility Form

- ▶ Reviewed by HHS team members and recent family applicants
- ▶ Easier for parents to use
- ▶ Provides improved directions
- ▶ Meets ADA accessibility requirements

CCA Provider Agreement

- ▶ Reviewed by HHS and some child care facility owners/directors
- ▶ Simplifies the “rates table” to determine reimbursement rate
- ▶ Provides improved directions
- ▶ Meets ADA accessibility requirements

Child Care Assistance (CCA) Pilot

Allows child care workforce to apply for CCA for their own children

- No family income limit
- All other CCA eligibility requirements must be met
- Families are assigned copays based on family income
