## **Meeting Proceedings**

### ***Welcome / Introductions***

Chair Aaron Johnson called the meeting to order at 9:06am. Amanda McKee reminded online participants to display their full names. Attendance was taken, and a quorum was confirmed.

Amanda Winslow proposed a change to the agenda to move Action Item "Tool O" to an informational item. The change was approved unanimously.

## **Public Comment**

**Deb Shrader:** At Condition of State Gov Reynolds praised ECI. Yesterday, local directors were told that Continuum of Care will be administered through Iowa Grants. Funds will be pulled from local services and that is not the intent.

**McKinley Bailey:** sent an email last night, will read it now. Appreciate the change in the agenda. Wants community collaboration and frank conversation.

**Carrie Kube:** 15 years as ECI director, has participated in thoughtful change in the past. These transitions require increase in time and participation. Change in director leadership has not been shared yet. If you approve moving to 7 districts today, we need funding for that transition.

**Patricia Russman:** 24 years, 9 county board with regional PAT affiliate, believed until yesterday that evidence-based family support would be protected. New funding formula given yesterday is over \$250,000 less than what we currently invest in our 9 counties. We would be able to serve 8 families per county and not meet our MIECHV requirements. Thought we were being good partners, feels like we are being punished. I may have to terminate half of those contracts and lay off half of those staff.

**Laurie Nash:** not an official ECI director, filling that role now because we've lost 2 directors in 2 years due to uncertainty. This does not impact my job so that's not why I'm here. Our county relies on that funding for a number of services for very at-risk families. There are no other options if we lose these programs. Feel that what we've been telling families is now not true. This could decimate the system and that has me concerned.

**Kerri Hall:** speaking on behalf of programs served with ECI funding in Ida and Woodbury counties to serve the most at risk and vulnerable youth. We've been told by Sen. Evans that there will be other funding to sustain these programs. When we saw the budget yesterday, that isn't close to what is needed to sustain programs. Please give us a little more time. Please allow ECI funds to be status quo for FY26 so we can create a runway.

**Barry Anderson:** Started with introduction of self then expressed lots of concerns with funding and timing. Make sure this doesn't just get pushed through.

**Tammy Wetjen-Kesterson:** Been a part of the ECI from beginning. Shocked yesterday that proposed Continuum of Care dollars would not be administered locally rather by the state. Top-down approach risks loss in funding with school partnerships or registered homes which will cause a breakdown of our fragile infrastructure that we've built in our communities.

## **Funding Formula Proposal**

Amanda Winslow presented:

- Strategy to expand evidence-based home visitation (Healthy Families America and Parents as Teachers)
- Proposal to merge Early Childhood and School Ready funds into a single, unrestricted fund
- Formula prioritizing areas with three or more risk factors at birth

## **Legislative & Board Concerns:**

- Rep. Bergan questioned the removal of land size from the formula
- Jennifer Banta and others cited limited review time
- Melissa Miller asked about short-term program support
- Dave Muhlbauer questioned the need to bundle all changes into one vote
- The board discussed the pros and cons of using data to inform decisions. The proposed new formula was based on 33% calculated for the 0-5 aged population per county, 33% calculated for the 0-5 aged population per county at 185% of the federal poverty level, and 34% calculated on utilizing data from Iowa's Integrated Data System for Decision-Making (I2D2) with known 3 or more risk factors at birth, per county. This approach applies funding to be distributed to counties with relevant needs for the age group and factors focused on early childhood.

**Final Motion:** Approve updated funding formula, combining Early Childhood and School Ready into one fund, using a risk-based formula, and including SFY25 carry-forward funds to go into an unrestricted bucket for use in SFY26, per an approved budget.

**FY26 PD Funds Usage**

Annually, there is a reserve of up to \$825,030 for state-level professional development support for the early childhood workforce via an array of initiatives aligned with the focus of early learning; health, mental health, and nutrition; special needs; and family support. The SFY2026 use of professional development funds were shared to be used for the following purposes: Infant and Early Childhood Mental Health endorsement and professional development (\$101,050), DAISEY data base update and maintenance (\$50,000), the Iowa Family Support Credential (\$175,000), T.E.A.C.H. Early Childhood Iowa (\$339,000).
