

# Brain Injury Advisory Committee Report

Presented to the Iowa Health & Human Services (HHS) Council

Date: August 20, 2025

#### **Committee Meeting Summary**

The Brain Injury Advisory Committee convened on July 31, 2025, to review current activities of the Iowa HHS Brain Injury Program. Next steps for advancing planning efforts were discussed. Committee members also had the opportunity to share updates during the meeting.

#### **Brain Injury Needs Assessment Activities**

The Committee reviewed initial findings from the statewide brain injury needs assessment, which included a series of listening sessions held in June 2025. These sessions engaged 93 participants across six in-person events held in various regions of the state, as well as three virtual sessions conducted via Microsoft Teams.

A SWOT (Strengths, Weaknesses, Opportunities, Threats) analysis was used to guide facilitated discussions, resulting in the identification of several key themes. A summary of these themes is included in Attachment A.

In addition to the listening sessions, a survey is currently in the field to gather additional input from individuals with brain injury, family members and unpaid caregivers and professionals and service providers supporting individuals with brain injury.

Available incidence and prevalence data, as well as Medicaid Brain Injury Waiver data, will be analyzed as a part of the brain injury needs assessment process.

## 2026-2030 Brain Injury State Plan Development

The Committee is preparing to hold regular working meetings throughout Fall 2025 to support the development of the 2026–2030 lowa Brain Injury State Plan. The goal is to have a draft plan completed by December 2025 for review and feedback.

### **Advisory Committee Membership Recruitment**

An application process has been developed to recruit new members for the 2026 Brain Injury Advisory Committee. This outreach will seek to ensure representation from:

- Individuals with lived experience
- Brain injury service providers
- Other stakeholders with relevant expertise or interest

The call for applications will begin in September 2025, with applications accepted through early November. A list of recommended appointees will be submitted to the HHS Council for review and approval at the November 2025 meeting.

## Brain Injury in Iowa: 2025 Listening Session SWOT Analysis Results

#### **Background & Method**

In June 2025, staff from the Iowa Department of Health and Human Services' (Iowa HHS') Brain Injury Program conducted six in person and three virtual listening sessions to gather input from community members across Iowa about life after brain injury. Over 90 individuals living with brain injury, family members, service providers and other advocates participated in the listening sessions.

Through a facilitated SWOT (Strengths, Weaknesses, Opportunities, and Threats) analysis, this report provides a high-level overview of the key themes that emerged.

- Employment and reentry planning
