INTRODUCTION

This guide is designed to help consumable hemp retailers and distributors submit and renew their registration, as well as maintain and edit their product lists pursuant to [641 IAC 156](#). Retailers and Distributors will select items from the Master Product List for retail sale and distribution. Products included in the Master Product List have already been reviewed for their compliance. Retailers and Distributors cannot sell products that are not included in the Master Product List.

Retailers and distributors are required to submit a product list upon the registration of their facility, as well as maintain up-to-date product lists throughout the duration of their registration.

Retailers and Distributors selling products that are not selected from the Master Product List are in violation of 641 IAC 156.2(1)c. and 2(2)c, which requires Retailers and Distributors to maintain a complete and up-to-date list of products.

Retailers and Distributors in violation of these rules are subject to enforcement, confiscation, and criminal or civil penalty.

Manage Your Products

Prior to Approval, consumable hemp registrants must submit a complete list of consumable hemp products the retailer or manufacturer intends to sell. This product list must include jurisdiction of origin and product certificates of analyses.

- HF2605 made several changes to the consumable hemp program. When creating or maintaining product lists, please keep the following changes in mind:
 - The maximum total THC permitted per serving is four (4) milligrams per serving and ten (10) milligrams per container. This includes Delta-9 THC and 87.7% of THCA. (See Iowa Code 204.2).
 - Synthetic consumable hemp products, such as products containing Delta-8 THC, Delta-10 THC, Hexahydrocannabinol (HHCH), Tetrahydrocannabiphorol (THCP), and Tetrahydrocannabinol-O-acetate (THCO), and other synthetic and semisynthetic cannabinoids are prohibited from sale in Iowa after July 1, 2024. This is not a comprehensive list of prohibited synthetic and semisynthetic cannabinoids. (See Iowa Code 204.14A).
 - Raw or dried flower form of hemp is not permitted in the consumable hemp program. Any raw or dried hemp flower marketed or distributed in Iowa must be sold as a raw or dried agricultural commodity and have a notice stating it is not suitable for consumption. Raw or dried flower marketed for introduction into the human body will be in violation of 641 Iowa Administrative Code 156. (See Iowa Code 204.14A).

Please refer to the [Consumable Hemp Product List Guide](#) for specific information required on the product list. Please also refer to the [Consumable Hemp FAQ](#) for additional information.

With a retail facility license, you can only select products from a pre-approved list. Custom product creation is not permitted, and you are only allowed to sell items from that list.

By electronic signature, the signatory is attesting that they understand the following requirements of consumable hemp registrants, and will not engage in the following prohibited activities pursuant to 641 Iowa Administrative Code 156, and that engaging in prohibited activities is grounds for embargo or suspension of the registration:

Requirements of Consumable Hemp Registrants

The undersigned attests acknowledgment of the following requirements:

- Submission and maintenance of a complete list of all consumable hemp products the consumable hemp retailer intends to sell, along with documentation of the jurisdiction of origin for each consumable hemp product (See 641 IAC 156.2)
- A consumable hemp registration is not transferable to a new owner or new physical location. The registrant will notify the Bureau of Cannabis Regulation will be notified by the registrant with any changes in ownership or physical location to my registration (See 641 IAC 156.2(6))
- It is prohibited to sell, give, or otherwise distribute consumable hemp products to individuals under the age of 21 (See Iowa Code 204.14D)

Consumable Hemp Registrant Prohibitions

The undersigned attests that they will not engage in any of the following prohibited activities:

- **Product-Specific Prohibitions**
 - Manufacture, distribute, or sell consumable hemp products with a total THC (accounting for all derivatives and isomers of THC) greater than 0.3% (See 641 IAC 156.3);
 - Manufacture, distribute, or sell consumable hemp products with a total THC (accounting for all derivatives and isomers of THC) that exceeds four milligrams per serving and ten milligrams per container on a dry weight basis (See Iowa Code 204.2);
 - Manufacture, distribute, or sell consumable hemp products containing synthetic or semi-synthetic cannabinoids (See 641 IAC 156.1);
 - Manufacture or sell consumable hemp products intended or advertised for inhalation, including all forms of vaporization or combustion, including but not limited to: forms of vaporization (disposable, pod-based, cartridge-based, etc.), and forms of hemp flower or cigarettes intended for combustion (See Iowa Code 204.14A);
 - Sell consumable hemp products manufactured in countries other than the United States of America; or
 - Sell any consumable hemp product not currently registered with Bureau of Cannabis Regulation (See 641 IAC 156.6(2)(d))
- **Marketing and Advertising Prohibitions**
 - Market a consumable hemp product as intended to cure, treat, mitigate, prevent disease or affect the structure or function of the human body (See 641 IAC 156.6(2))
- **Premises Prohibitions**
 - Manufacture or sell consumable hemp on the premises of a temporary location, including a food stand, roadside stand, temporary booth, or any other temporary structure, including: door-to-door, vending machines, or private parties. Farmer's markets have specific exemption requirements. (See 641 IAC 156.6(1),(2)); or
 - Manufacture or sell consumable hemp on the premises of a private residence, except a portion of a private residence that is distinctly separate from any living space (See 641 IAC 156.6(1))
- **Applicability with other Laws**
 - Introduce consumable hemp into any of the following:
 - Meat or Poultry product for which the individual or entity is subject to Iowa Code chapter 189A (See 641 IAC 156.5(2));
 - Dairy product for which the individual or entity is subject to Iowa Code chapters 190 to 192 (See 641 IAC 156.5(4)); or
 - Alcoholic Beverage product for which the individual or entity is subject to Iowa Code chapter 123 (See 641 IAC 156.5(2)).

Products will be reviewed by the Department using the laws and regulations currently in effect on the date that the products are reviewed. It is the responsibility of the registrant to keep informed of any changes to the laws and regulations of the consumable hemp program and to adjust product lists accordingly.

By signing below, I certify under penalty of perjury that the information on this registration is complete, true, and submitted for the purpose of obtaining a State of Iowa Consumable Hemp Registration. I understand that providing false or misleading information may result in the denial, cancellation, or suspension of my Consumable Hemp Registration and that the law provides severe penalties (fine and/or imprisonment) for the willful submission of known false information.



Prohibited Product	Citation	Penalty
Inhalable Products	Iowa Code 204.14A	Serious misdemeanor, civil penalty of up to \$2,500 per violation, confiscation and disposal of non-compliant products, and/or suspension or revocation of future registrations

Retailers and Distributors selling products that are not selected from the Master Product List are in violation of 641 IAC 156.2(1)c. and 2(2)c, which requires Retailers and Distributors to maintain a complete and up-to-date list of products.

Retailers and Distributors in violation of these rules are subject to enforcement, confiscation, and criminal or civil penalty.

iv. Liquids and Beverages, Less and Greater Than 12 oz.

Statute and Administrative rule do not further define or indicate that any “liquid consumable hemp product” is exempt from the requirement for the container to be a minimum of 12 fl oz. This means that regardless of serving sizes indicated in Table 2 for a liquid consumable hemp product, the container must be 12 oz or greater to be compliant and added to a product list.

Additionally, for any liquid consumable hemp product packaged in a container >12 oz and containing greater than one serving, the incremental increase in THC potency shall not exceed the following volume-potency increments listed in Table 1:

16 oz	1.33	5.33 mg
20 oz	1.66	6.66 mg
24 oz	2.0	8.00 mg
30 oz	2.5	10.00 mg

Regardless of the serving size indicated in Table 2, beverage or liquid products packaged in containers >12 oz may not use a multiple of a serving size <12 oz (“juices, fruit drinks, syrups, drink mixes, etc.) as indicated by the standard 12 oz serving size for “beverages.” Some examples are provided below:

<i>Drink mix, syrup</i>	4 oz, 4 mg	1	No, container <12 oz

HHS does not have authority to provide flexibility for variance from the 4 mg THC per serving or 10 mg THC per container limit. Compliant products must contain a COA that indicates less than those serving limits for a compliant volume-potency claim, or rounds down to those limits. Some examples are provided below:

Examples:

Beverage, 10 oz	2.5 mg	2.5 mg	No, container <12 oz
Beverage, 12 oz	4 mg	3.85 mg	Yes

Beverage, 12 oz	4 mg	4.06 mg	No, >4 mg THC/serving
Beverage, 16 oz	5 mg	5.13 mg	Yes
Beverage, 16 Oz	5 mg	5.41 mg	No, >4 mg THC/serving

Additionally, lipid and oil-based “tincture” products are “ingestible fats and oils” and exempt from 12 oz minimum container requirements.

Conclusion

- Liquid products must be in containers that have 12 oz or more in volume, regardless of the indicated serving size in Table 2. 12 oz containers may have less <4mg THC, but not more.
- Liquid products in containers >12 oz may increase the THC potency to correlate with the volume-potency table above
- Liquid products in containers >12 oz may not use a suggested serving size from Table 2 that is less than the 12 oz serving for carbonated and non-carbonated beverages.
- HHS cannot offer flexibility for variance with the 4 mg THC per serving and 10 mg per container limit.
- Oil- or lipid-based tinctures are permissible in <12 oz containers and follow serving suggestions from Table 2.
