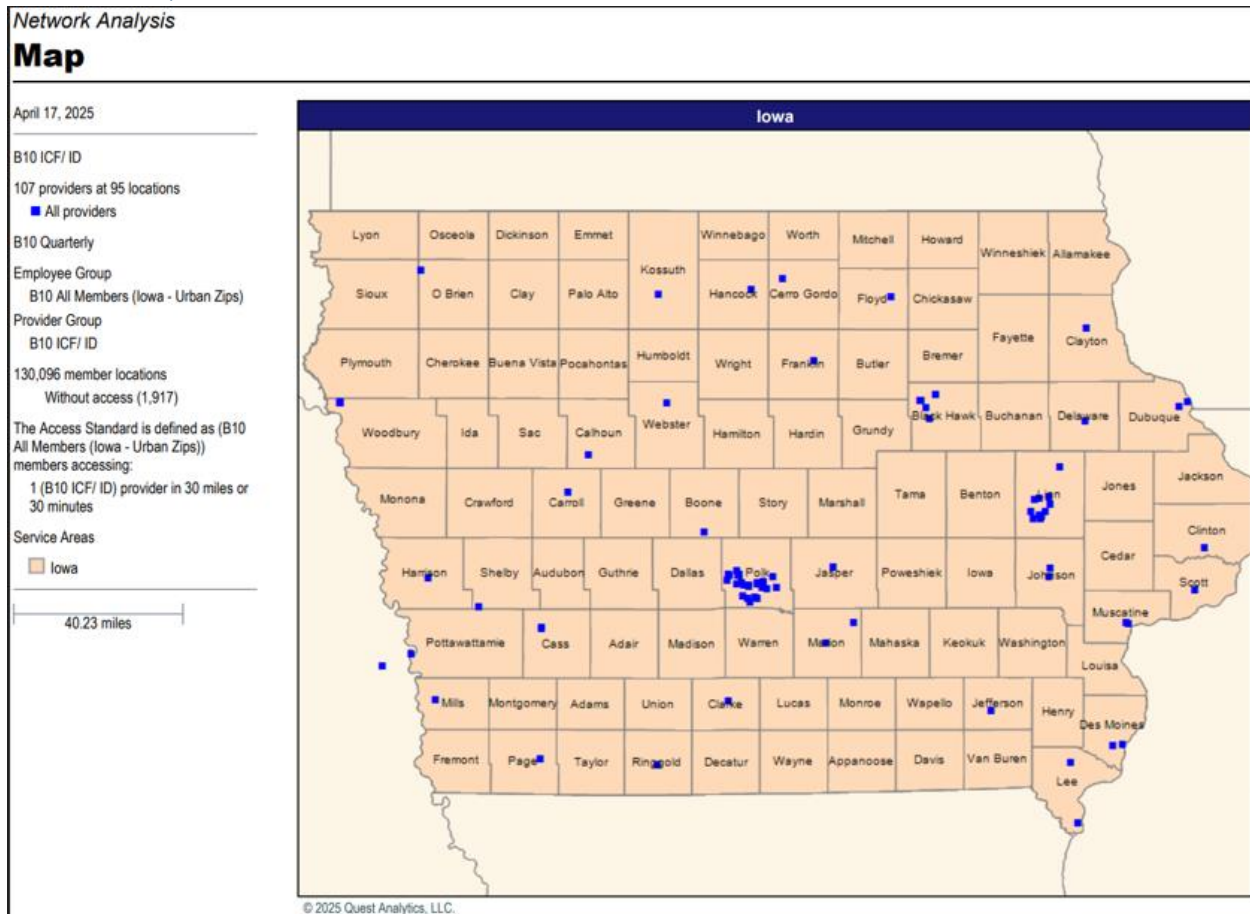


Table 1B Map: Waiver – Brain Injury – Adult Day Care – Urban - 30 minutes or miles: Less than 100% standard

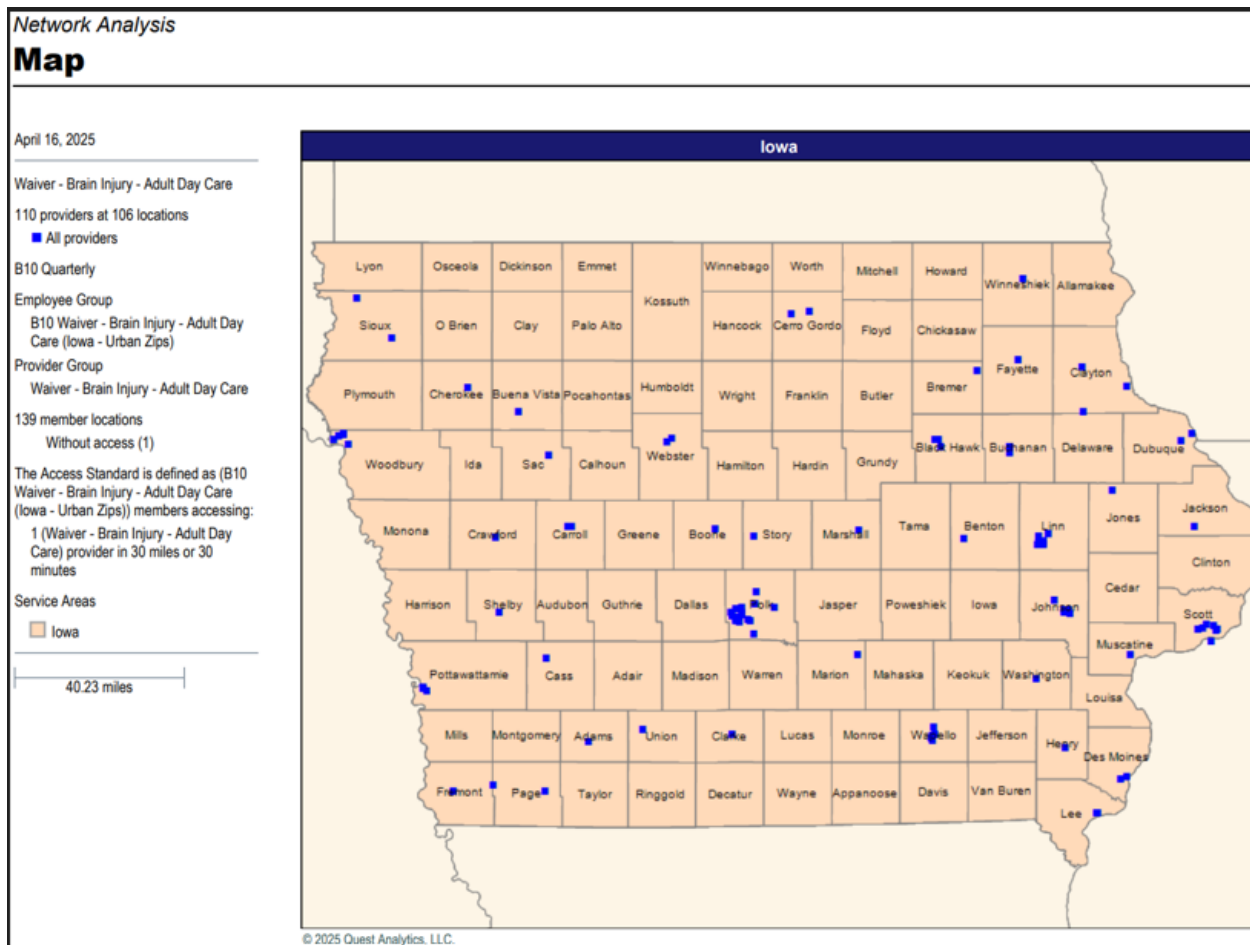


Table 1C Map: Waiver – Brain Injury – Supported Employment – Urban - 30 minutes or miles:

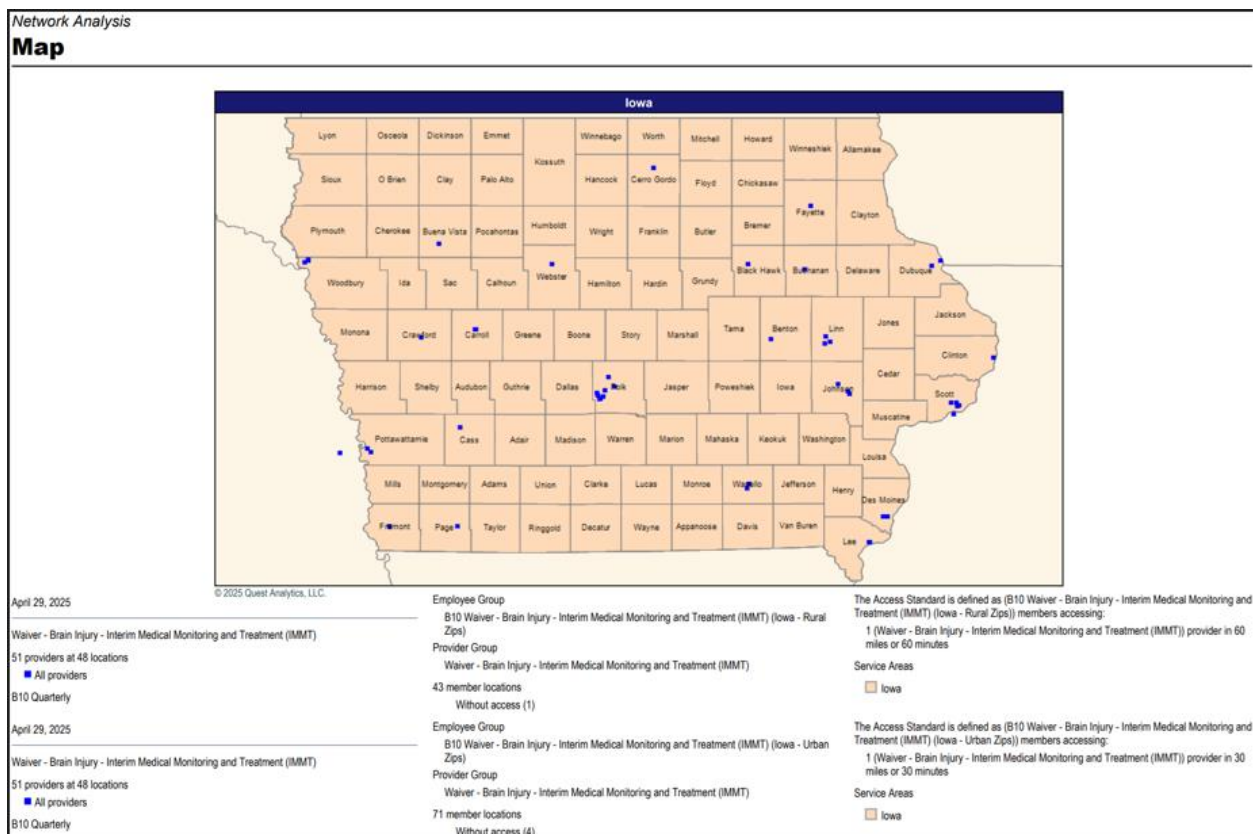


Table 1E Map: Waiver – Brain Injury – Respite – Urban - 30 minutes or miles: Less than 100% standard

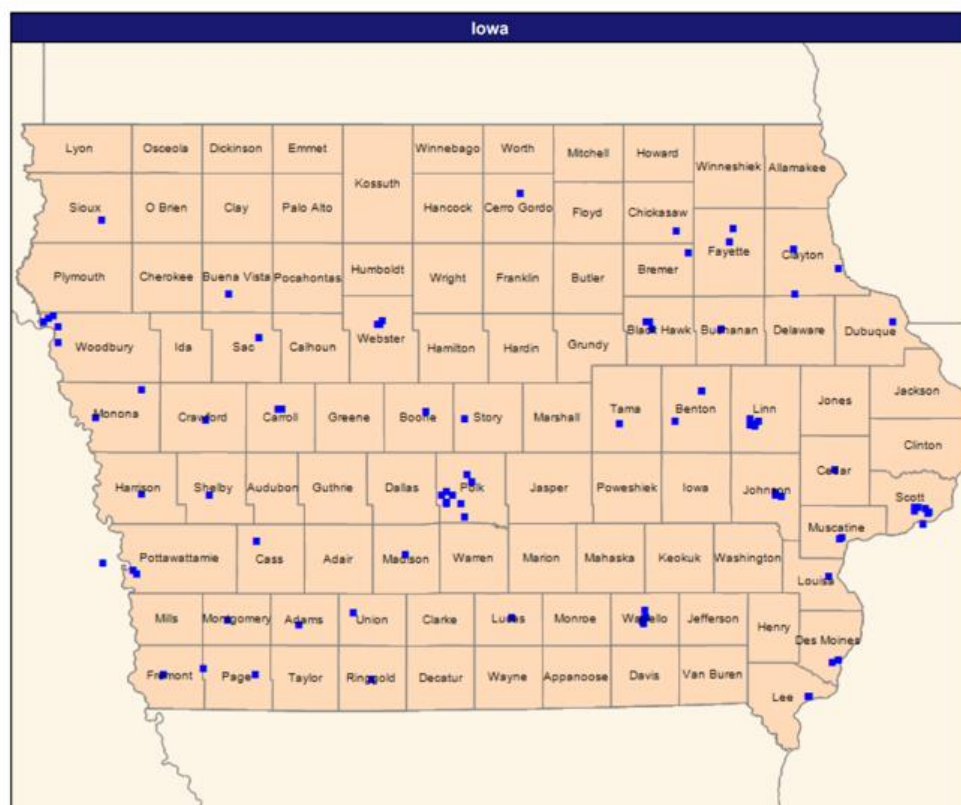

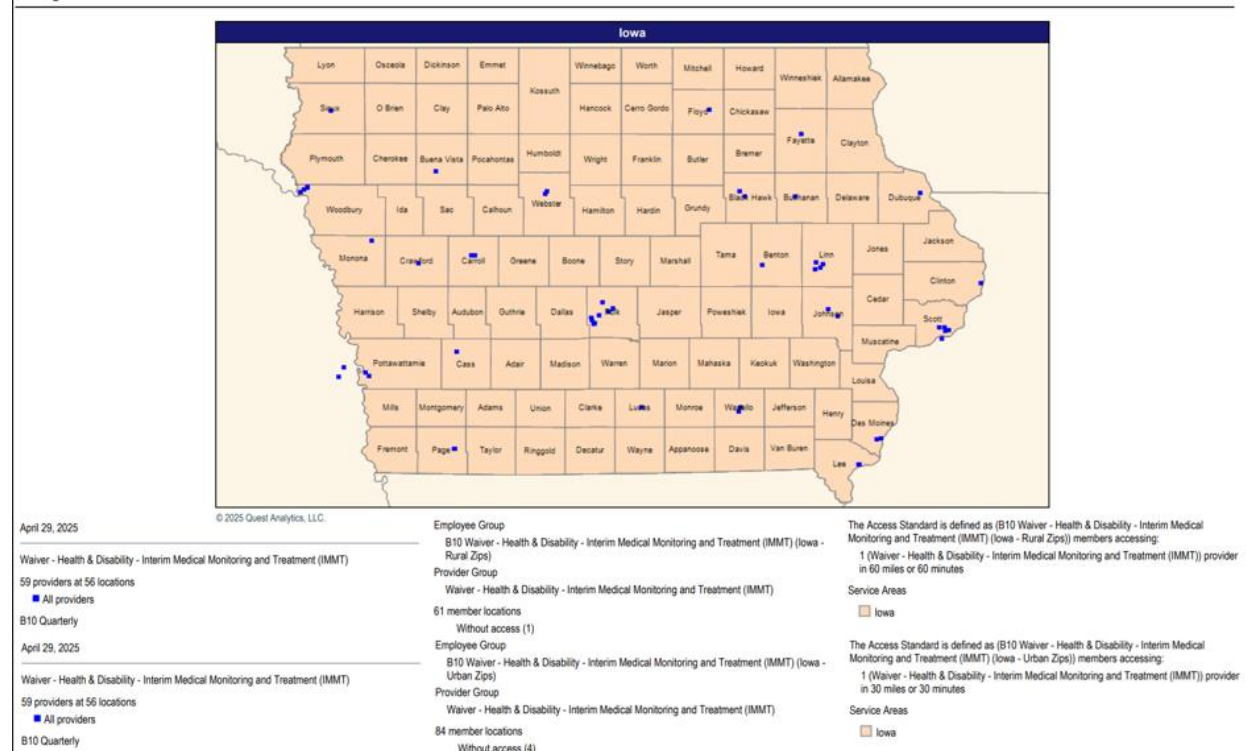

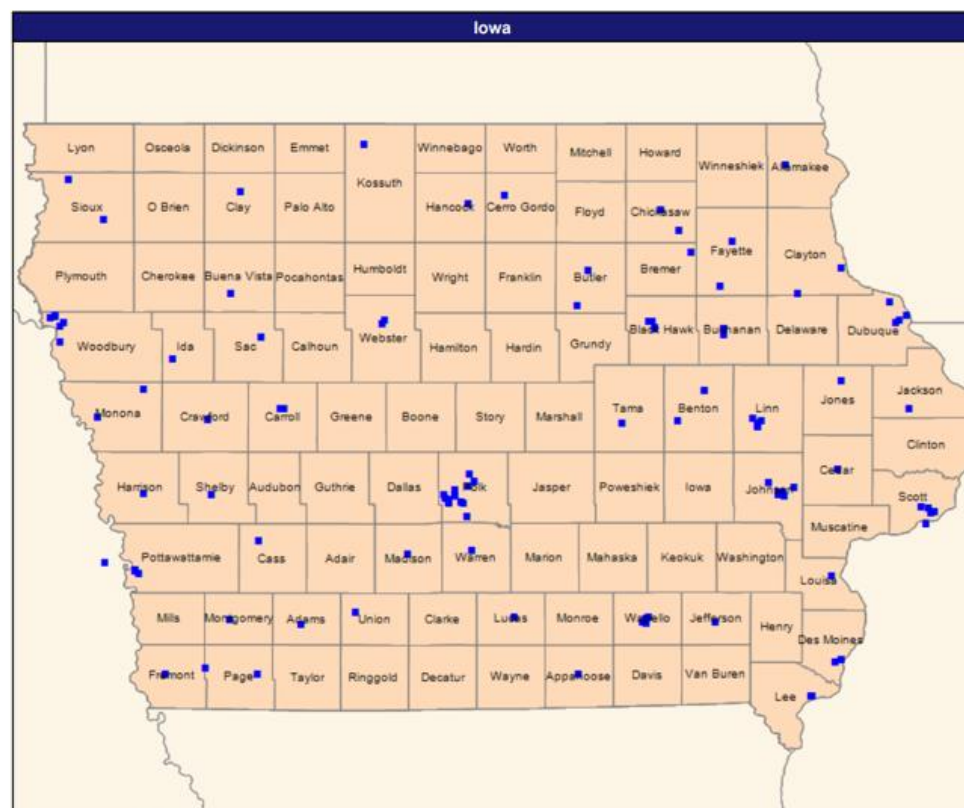

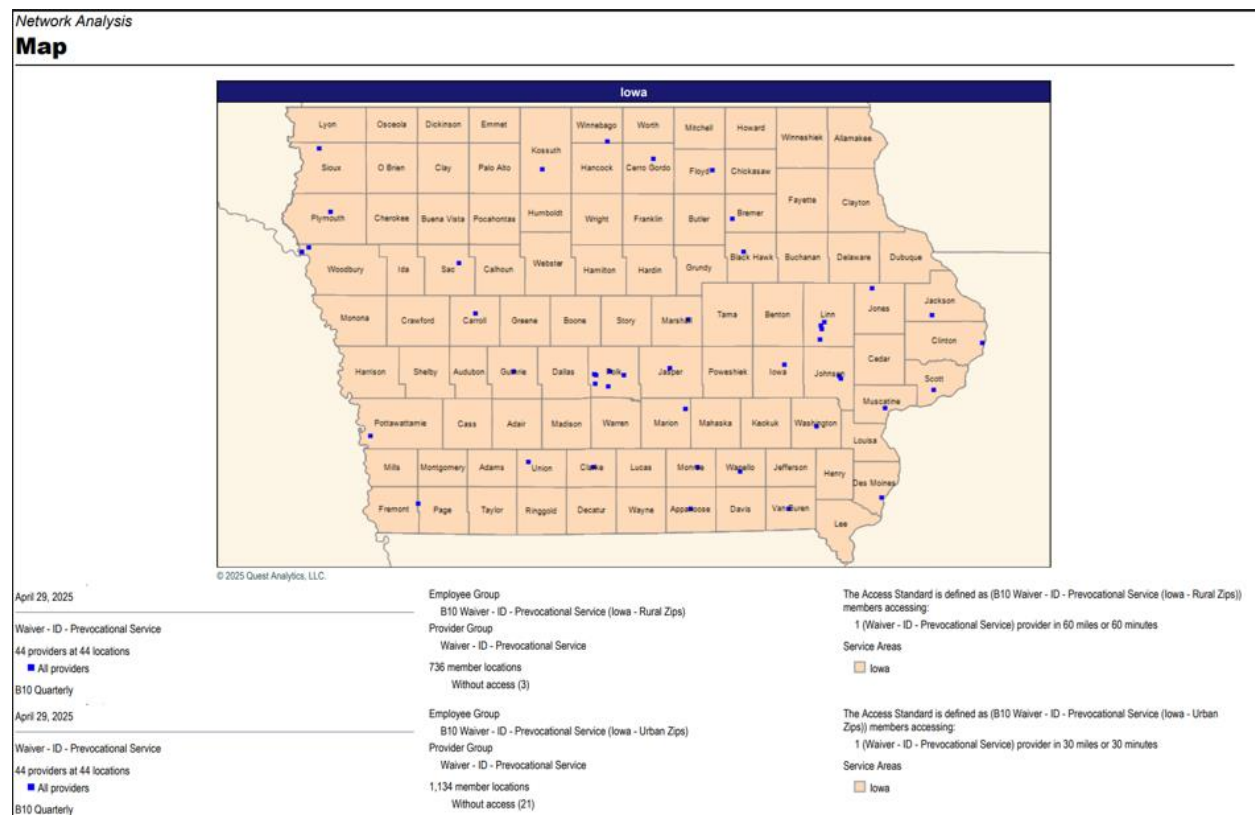


Table 1M Map: Waiver – Intellectual Disability – Supported Employment – Urban - 30 minutes or miles: Less than 100% standard

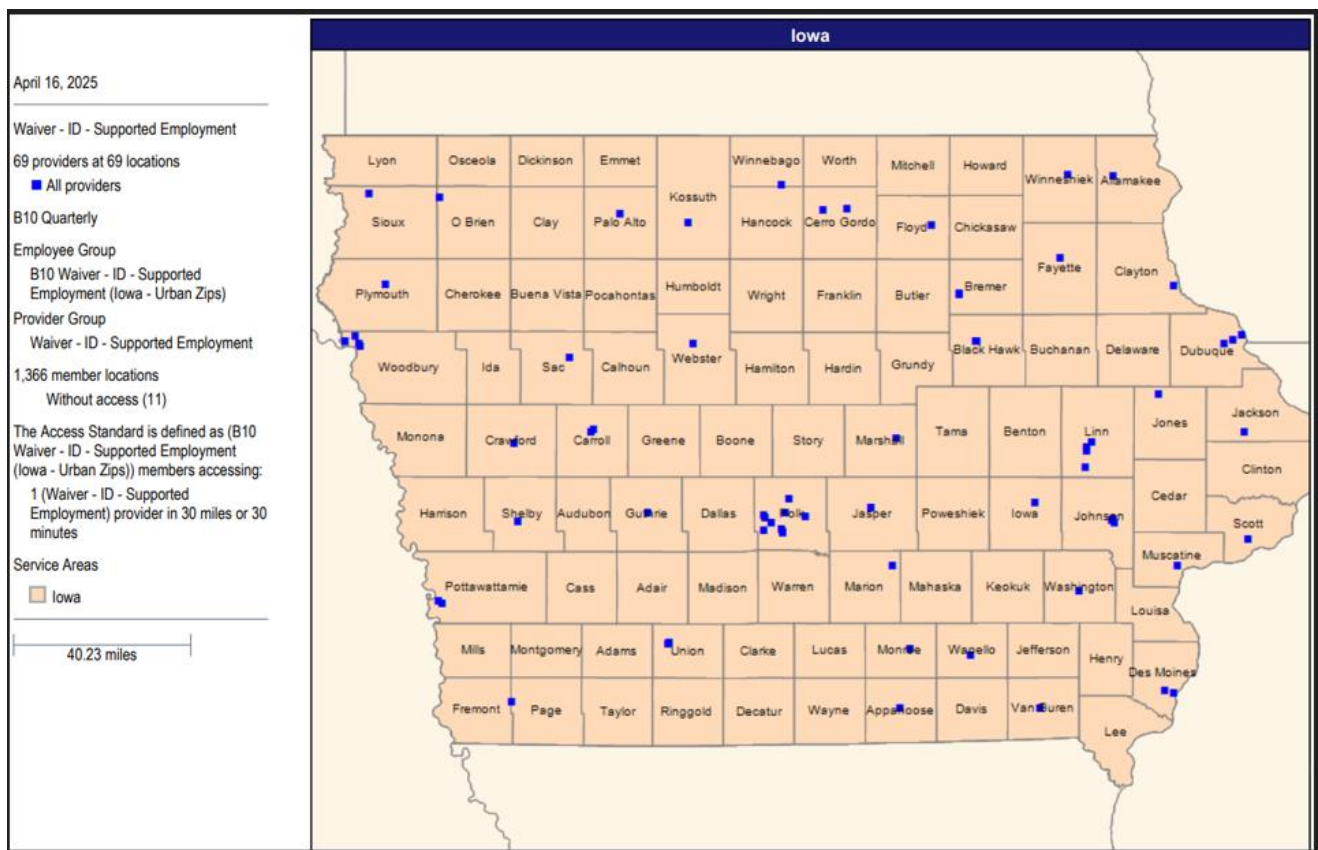


Table 1N Map: Waiver – Intellectual Disability – IMMT – Urban - 30 minutes or miles: Less than 100% standard

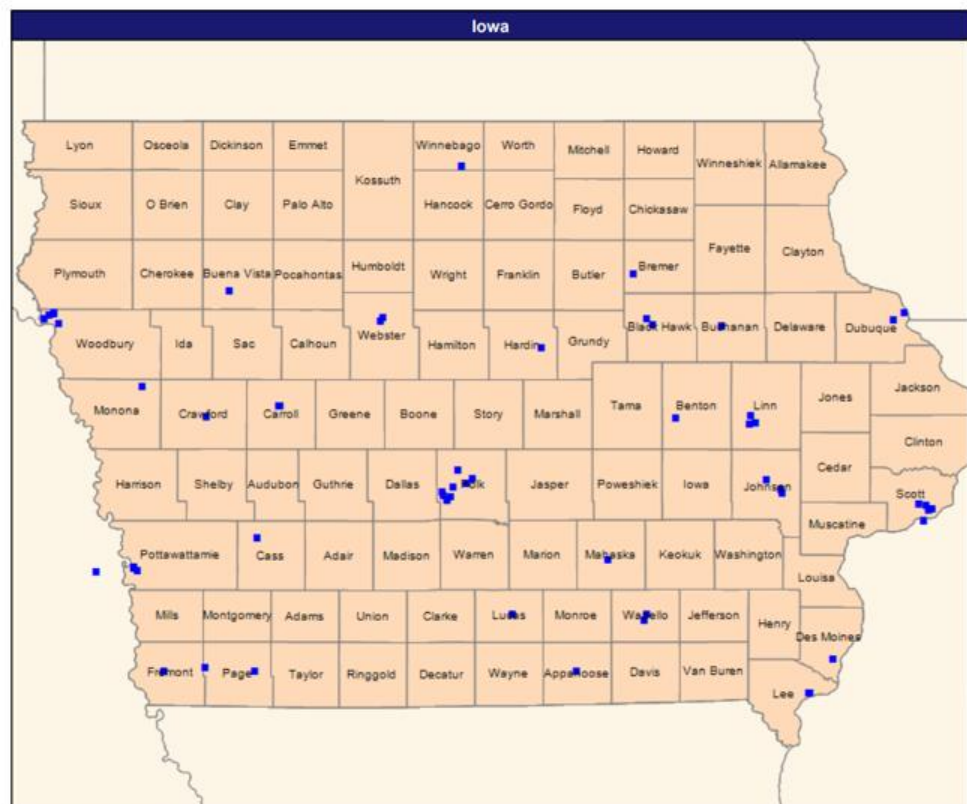

Table 10 Map: Waiver – Intellectual Disability – Respite – Urban - 30 minutes or miles: Less than 100% standard

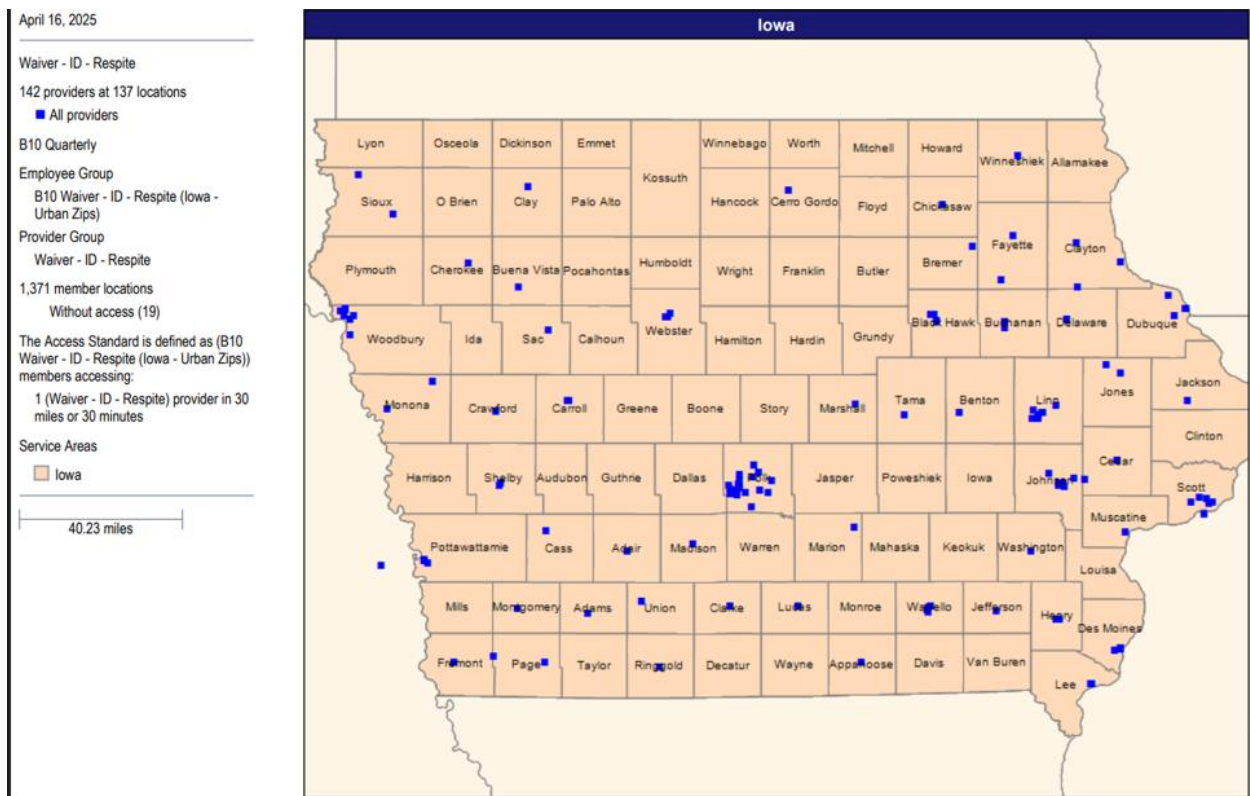


Table 1P Map: Waiver – Intellectual Disability – Transportation – Urban - 30 minutes or miles:

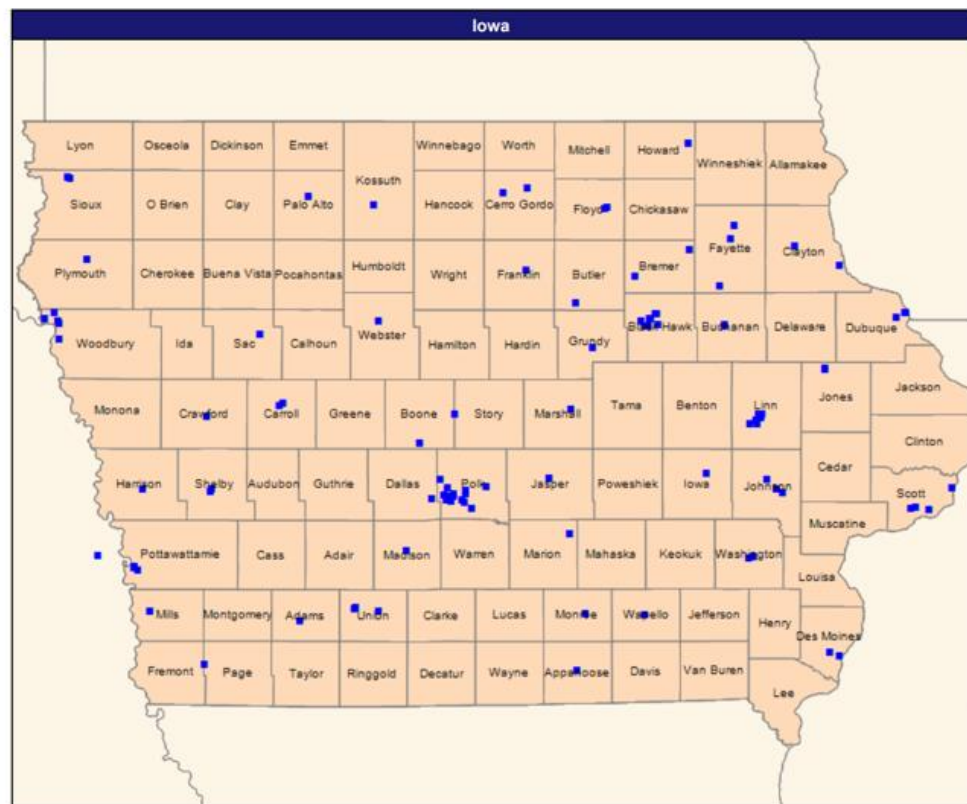

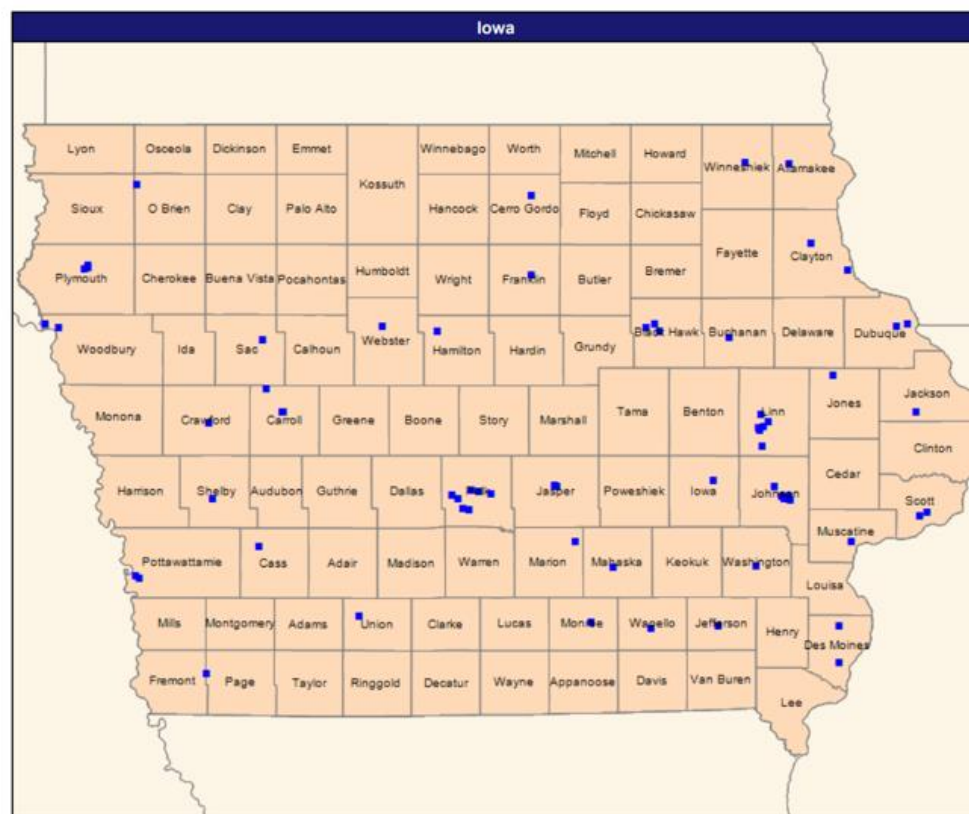

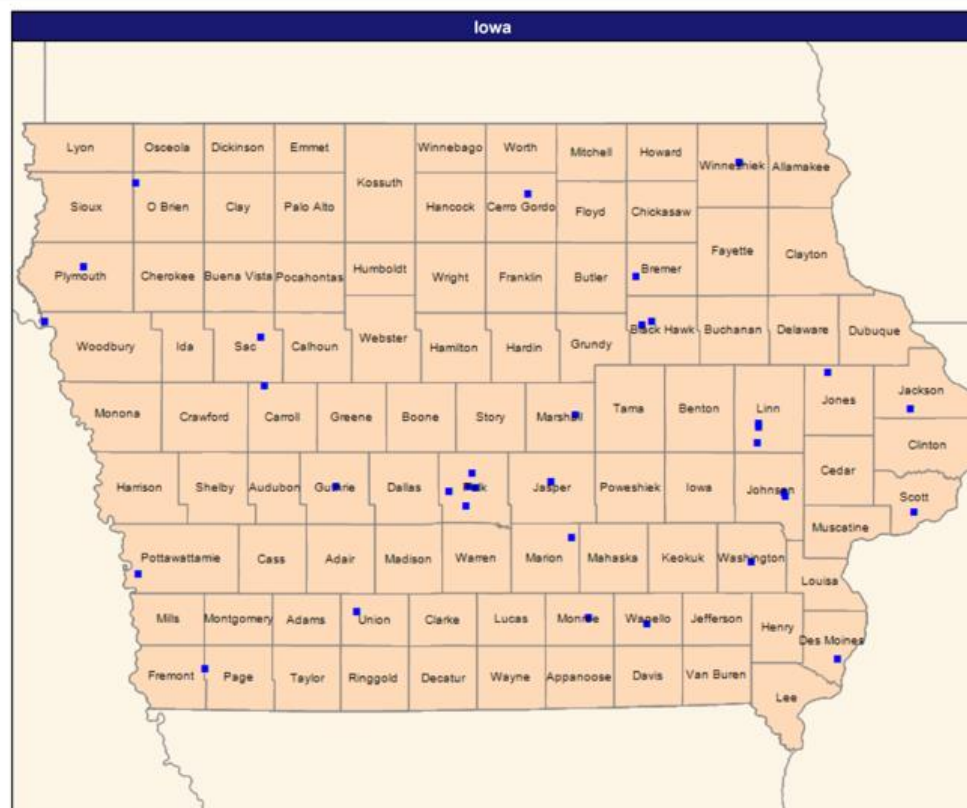
