REACH Timeline

- ► Last month, we discussed a high-level timeline for REACH which is summarized below:
 - 2026: HHS and Subcommittees make decisions on REACH implementation
 - 2027: Early adopters begin REACH implementation
 - 2028: Full REACH adoption has a target date of July 1, 2028
- ► With this timeline, HHS is still making decisions and likely won't have communication materials on the specific elements of REACH until later in 2026
- ► We are looking for feedback on our plan for communications and the role of the communications subcommittee during this planning phase.



2026 Communication Plan

- ►HHS will continue to socialize REACH with key groups and community members through the roadshow and town halls
 - o Questions and answers will be posted to the website
- ►HHS will share timeline information with providers and potential enrollees
- ►HHS will prepare potential communication materials as decisions are made (likely late 2026)

Communications Subcommittee in 2026

- ▶ Option 1: Continue Communications Subcommittee discussions on an as-needed or bimonthly basis
- ▶ Option 2: Move Communications Subcommittee discussions to other committees, such as the Consumer Steering Committee, as communications materials are ready
- ▶ Option 3: Temporarily close the Communications
 Subcommittee and reconvene in late 2026 once HHS is ready
 to communicate on specifics of the REACH program
