

# Iowa Behavioral Health Safety Net Management Information System (SNMIS)

## Behavioral Health Services Fee Schedule (effective 4/1/2026)

Crisis, treatment, and recovery services provided by behavioral health providers may be billed based on the following fee schedule.

Providers may only bill for services for which they are qualified under the scope of their licensure, certification, or accreditation and adhere to the Iowa Medicaid service-specific policies, unless otherwise specified in the [SNMIS Billing Guide](#). Providers must be enrolled under the applicable Iowa Medicaid provider type for the service and be registered for the SNMIS line of business.

All claims on this fee schedule must be billed on the Professional claim form unless otherwise noted in the Billing Requirements and Limitations column.

New additions are highlighted in yellow and are effective for dates of service beginning 4/1/2026.
