

# Iowa Behavioral Health Safety Net Management Information System (SNMIS)

## SUPTRS Fee Schedule (effective 4/1/2026)

Iowa HHS has allocated a portion of the SUPTRS Block Grant to subsidize the cost of substance use disorder (SUD) treatment services. Designated SUD treatment providers, who have an existing infrastructure designed to meet the SUPTRS federal regulations,

These providers must ensure residential treatment services are readily accessible, comprehensive, appropriate to the persons seeking the services, flexible to meet the evolving needs of patients, and effective. Residential treatment must be available when needed, with minimal wait times, regardless of available funding. Providers must adhere to the policies specified in the [SNMIS Billing Guide](#) and be registered for the SNMIS line of business.

All claims on this fee schedule must be billed on the Professional claim form.
