If the apparent successful bidder fails to negotiate and execute a contract with the Agency, in its sole discretion, the Agency may revoke the Notice and enter into contract negotiations with another bidder or withdraw the RFP. The apparent successful bidder(s) is advised that no project activities may be initiated, and no funds may be obligated or expended, until a written contract has been fully executed by all parties.

Any work performed or costs incurred prior to contract execution shall be at the bidder's sole risk and will not be reimbursed by the Agency. The Agency further reserves the right to cancel the Notice at any time prior to the execution of a written contract.

Reconsideration of Award Decision.

Respondents to this procurement may request reconsideration of this intent to award decision by submitting a written request via email to:

The Agency must receive the written request for reconsideration within five calendar days of the date of a notice of intent to award, exclusive of Saturdays, Sundays, and legal state holidays. Do not deliver any requests for reconsideration to the office in person. It is the Respondent's responsibility to ensure that the request for reconsideration is received prior to the deadline.

The request for reconsideration shall clearly and fully identify all issues being contested by reference to the page and section number of the RFP. If a Respondent submitted multiple Proposals and requests that the Agency reconsider a notice of intent to award decision for more than one Proposal, a separate written request shall be submitted for each. At the Agency's discretion, requests for reconsideration from the same Respondent may be reviewed separately or combined into one response. The Agency will expeditiously address the request for reconsideration and issue a decision. The Respondent may choose to file an appeal with the Agency within five calendar days of the date of the decision on reconsideration, exclusive of Saturdays, Sundays, and legal state holidays, and in accordance with 441 Iowa Admin. Code Ch. 7.
