3. Approval of Minutes

Mike McKelvey, Chair

Dr. Richards made a motion to approve the February 11, 2022 minutes, with a second by Dr. Shreck.

A verbal vote was taken. Motion carried unanimously.

#### 4. Public Comment Period

#### Mike McKelvey, Chair

- **Peter Komendowski** Peter thanked the Board for their work. Peter encouraged the Board to keep risk assessment and consequences in-mind when making decisions about program expansion, and to be aware of the issues related to cannabis and THC.
- Maggie Ballard Maggie is a prevention specialist. She spoke to concerns with licensee marketing and advertising, particularly around the 420 holiday and encouraging recreational use. She expressed concerns about youth seeing the advertisements.
- John Fenner John spoke to concerns with practitioner knowledge around medical cannabis, and spoke to the his experience benefit from other product forms that aren't allowed in IA's program. He spoke to his preference for using cannabis, as opposed to narcotics, for treatment of his condition.
- **Carl Olsen** Carl spoke to the inconsistencies between State and Federal law regarding cannabis, and his desire for these issues to be reconciled by the Federal Government.

## 5. Program Updates

Owen provided context on the sales of THC-forward products, and that with IA's consumable hemp program up and running, and the availability of hemp-derived CBD products on-line, that patients may be purchasing CBD products from sources other than IA's dispensaries. Owen also spoke to the discrepancies between State and Federal law related to cannabis, and that changes to reconcile them would be wholesale as opposed to piecemeal; a Federal trigger in 124E to align lowa statutes with any would-be changes to Federal law could be considered to reconcile this issue.

Owen also updated the Board on the Department's plan to update administrative rules around licensee marketing and advertising, as well updates to language pertaining to the Department's seed-to-sale system. This packet of rules also allows practitioner authority for card cancellation, as well as Veteran access to the reduced fee option. Owen gave the Board a data update on key program metrics.

Dr. Shreck inquired about the increase in sales, and if hemp-derived cannabinoid products were contributing to those numbers. Owen explained that consumable hemp products are not tracked by the Department's seed-to-sale system, but are allowed to be sold in dispensaries. Dr. Richards inquired about THC tracking and testing of hemp-derived cannabinoid products, and Owen explained that regulation of these products is largely limited, but that states are discussing how to better regulate those products. He introduced the difficulties around regulating intoxicating hemp-derived products that are proliferating.
