I. Agenda/Minutes

Motion made by Ms. McGrath and seconded by Mr. Allen to approve the October 12, 2022 minutes as written. Motion carried unanimously.

II. Substance Use Disorder/Problem Gambling Licensure

A. Licensure Recommendations

1) One (1) Year License:

a. Motion made by Ms. McGrath and seconded by Mr. Allen to approve a license for a period of one (1) year to the following program: Crossroads Behavior Health Services, Creston, Iowa, license effective October 7, 2022 to October 7, 2023.

2) Two (2) Year License:

a. Motion made by Ms. McGrath and seconded by Mr. Allen to approve a license for a period of two (2) years to the following programs: Siouxland Counseling Services, PLLC, Sioux City, Iowa, license effective August 7, 2022 to August 7, 2024 and Integrated Treatment Services, LLC, Newton, Iowa, license effective August 9, 2022 to August 9, 2024.

3) Three (3) Year License:

6) Denial:

a. Motion made by Ms. McGrath and seconded by Mr. Allen to deny an application for a license to **Urban Dreams, S.A.F.E., Des Moines, Iowa,** in accordance with Iowa Administrative Code 641—155.10(1)(b) and 155.10(1)(d)(16). The committee may deny an application for a license when an applicant fails to achieve the minimum licensure weighting report rating required for a 270-day initial license, or a one-, two- or three-year license and failure to comply with a corrective action plan issued pursuant to rule 641—155.9(125,135) or 641—155.16(125,135).

(1) year to Elevate CCBHC, LLC, Waterloo, Iowa, license effective November 7, 2021 to November 7, 2022.

Staff report by Lori Hancock-Muck. The licensed program was represented by Bob Lincoln and Nicole Russel from Elevate CCBHC. The program made remarks. Motion carried unanimously.

III. Substance Use Disorder/Problem Gambling Update – DeAnn Decker

Ms. Decker gave an update on filling the third member vacancy on the SA/PG committee member as it is on the agenda for the upcoming Board of Health meeting. The SA/PG committee member will be representing the public as the other two committee members represent prevention and treatment.

Ms. Decker mentioned there are still ongoing discussions on what the SA/PG subcommittee will look like in the future with the Health and Human Services alignment.

Ms. Decker gave an update alignment of the Health and Human Services Department (HHS). Ms. Decker shared that she is working with Theresa Armstrong and Marissa Eyanson to review the organization chart and bureau budgets. Ms. Decker shared an employment satisfaction survey has been sent to HHS staff to complete to give feedback on the alignment. Ms. Decker discussed the open director positions are currently in the process of conducting interviews, and should be filled in the near future.

Ms. Decker shared she continues to meet with the Medical Director, Dr. Kruse, and the standing order for Naloxone has been renewed and is being distributed to schools, businesses, first responders, pharmacies and other locations.

Ms. Decker gave an update on the CCBHC planning grant she has been working on with Theresa Armstrong and Marissa Eyanson. The deadline for the grant is December 19, 2022. If awarded, the planning grant will last for one year in the amount of one million dollars. If awarded, they would apply for an implementation grant to move the program forward.

Ms. Decker shared many providers in the state are experiencing staff shortages and that the bureau is working with programs to address this ongoing issue.
