III. SABG Application and Comment – Michele Tilotta

Michele Tilotta, SABG and Synar Manager, Iowa Department of Health and Human Services/Bureau of Substance Abuse, provided a historical overview of the Substance Abuse Block Grant (SABG) for the members. Title XIX, Part B, Subparts I, II and III of the Public Health Service (PHS) Act, as amended, establishes the SABG program. Ms. Tilotta reviewed how SAMHSA envisioned a new way of providing services, including substance use and mental health, and established block grants to states in 1981.

Ms. Tilotta reviewed the SABG practices, timelines, and reports (application, report and annual Synar report) annually developed and submitted, the review process by SAMHSA, and the statutory authorities associated with the SABG. Statutory regulations reviewed including; Maintenance of Effort (MOE) requirements, primary prevention set aside, stakeholder input, set asides for specific populations or programs, and reviewed the priority populations.
