Approval of open session minutes

Rasmussen moved the approval of the open session meeting minutes of October 12, 2022. Fretheim and Rasmussen noted changes on page 3 of the meeting minutes. Langel motioned to approve the minutes as amended. A second was received by Duinink.

Administrative Rules

a. Notice to adopt ARC 6665C that amends Chapter 41, "Licensure of Chiropractic Physicians," of the application process and requirements for licensure by endorsement. The Board was advised the Governor announced there would be a moratorium and that guidance had not yet been received but could impact the rules being discussed.

Fretheim moved to adopt the changes to ARC 6665C and a second was received by Duinink.

New Business

a. Discussion on the procedure of venipuncture to determine if it is covered under a chiropractor's scope of practice.

The Board discussed venipuncture and the scope of chiropractic practice. Wondra discussed FDA and State of Missouri regulations. The informal consensus was that lowa chiropractors may draw blood (or order blood testing) but may not inject or administer any substance into the body. A chiropractor may recommend non-prescription, oral supplements, but cannot prescribe them to be injected or administered intravenously.

Closed Session Agenda

Wondra moved the Board go into closed session at 9:36 a.m. pursuant to Iowa Code Section 21.5(1)(a) to review or discuss records which are required or authorized by state or federal law to be kept confidential, pursuant to Iowa Code Section 21.5(1)(d), to discuss whether to initiate licensee disciplinary investigations or proceedings, and pursuant to Iowa Code Section 21.5(1)(d), to discuss the decision to be rendered in a contested case conducted according to the provisions of I7A. A second was received by Langel.
