The Board also discussed delegations for initial complaint actions including (1) forwarding complaints for formal investigation, (2) referring to law enforcement when a complaint indicates a crime was committed, (3) closing complaints that are facially inactionable or outside of the board's jurisdiction, (4) approving stop-practice agreements, and (5) approving rescheduling orders. The Board discussed the scope of delegations given to Board staff and situations when matters would be taken to the Board. Board consensus was to vote to continue delegating these approvals and actions to Board staff.

Schnurr moved to approve the Delegations of Authority to board staff as discussed. A second was received by Houge. All ayes, nays none, motion carried.
