Board Executive Report - Legislative Update

Alden reported on SSB3003, which proposes to establish a student loan repayment program for mental health professionals. He stated HF2225 proposes to merge the Boards of Social Work and Behavioral Science. Alden stated SF2529 proposes to add charges to assault cases of social work professionals.

Alden reported there are currently 2,366 active licensed independent social workers, 1,723 masters' level active licensed social workers and 641 active licensed bachelor level social workers.

Administrative Rules

Joint supervision rules ARC 6142C – Review of comments, motion to approve Board of Behavioral Science Adoption

Alden said 18 comments were received noting psychologist's exclusion as supervisors and six comments requesting a grandfathering provision for those currently receiving supervision. He noted additional comments were on the direct observation and direct client contact hours.

Raymer moved the Board approve the Joint Supervision Rules ARC 6142C as discussed, to include the addition of language to requests for supervisors

must be approved by the Board prior to the beginning of the supervised experience, 1500 direct client contact hours and including a grandfathering clause. A second was received by Begley. All ayes, nays none, motion carried.
