Exchange Data with IRIS

Electronic health record (EHR) systems can exchange immunization data directly with Iowa's Immunization Registry Information System, IRIS. Data exchange allows health care providers to send and receive (bidirectional) immunization information for patients.

Save Time

- Access consolidated immunization information directly in the EHR. EHRs can automatically send immunization information to IRIS and query IRIS for patients' immunization records.
- Access immunization forecasting directly in the EHR. Data exchange allows comprehensive patient immunization records to be available in the EHR and does not require users to log in IRIS.

Save Money

- Once bidirectional exchange is established, it's free. IRIS does not impose fees to set up or maintain bidirectional exchanges. Note: Initial expenses may be imposed from technical staff and EHR vendors during the set-up process. Most EHRs include functionality to support electronic data exchange with immunization registries.
- Having a bidirectional connection with IRIS helps meet requirements for federal incentive programs. Stage 2 Meaningful Use attestation of immunization reporting requires a bidirectional connection with IRIS.

Support Immunization Practice

- Prevent duplicate vaccinations. Having information from IRIS in the EHR allows clinicians to easily assess a patient's consolidated immunization history and avoid receiving unnecessary vaccinations.
- Ensure the right vaccines are given at the right times. The immunization forecasting information in IRIS can feed directly into the EHR to support clinical decision-making. Forecasting assesses patient vaccine history and recommends vaccine patients are due or past due to receive.

Support Public Health

 Support immunization improvement efforts and vaccine-preventable disease outbreak responses. IRIS helps avoid disease outbreaks by providing accurate, up-to-date information about the immunizations individuals receive.
