

# Meeting Norms

## Implementation activities

Develop streamlined screening and processes

#### Activities:

- Screen people on Medicaid HCBS waitlists to understand their needs
- Implement new policies to prioritize waiver slots for people who are most at risk of entering a facility
- Develop data systems to support waitlist processes

Align CBS to the needs of lowans

#### Activities:

- Change waivers and waiver service offerings to meet people's needs
- Assess financial impact of changes to the system
- Create a universal assessment tool to determine whether someone may receive a waiver

### Maximize access to CBS

#### **Activities:**

- Identify resources to help people identify services they need
- Train people to support system navigation
- Develop a program to train case managers
- Decide how many people each case manager should support



Point in time (PIT) screening




# lowa needs to know more about the waitlist population to improve policy and services

- In 2022, there were more than 18,000 waiver slots requested across all five 1915(c) waivers.
- More needs to be known about the individuals waiting for these slots.
- Information about individuals currently on the waiting list will help lowa improve screening and better align waiver services with people's needs.



#### The PIT screening will identify the needs of individuals on the waiver waitlist

- Screening results for individuals currently on the waitlist will be used to refer/connect to other non-Medicaid funded services (e.g., MHDS)
- After collecting feedback from Invested Iowans, we will design a plan to conduct the point-in-time screenings
- The next step is to identify the actual screening tool and key elements of our approach





#### States take different approaches to screening tools

Goal: Learn about the HCBS screening tools used by other states to select a tool for the PIT screening of individuals on HCBS waiver waitlists.

#### Research on screening and assessment practices revealed two conclusions.

- 1. States tend to use three options for developing screening tools: using preexisting tools, customizing their own tools, or building new tools
- 2. All tools generally measure similar domains (ADLs, IADLs, health, behavioral health), but vary in length and how they can be used
- ADLs Activities of Daily Living
  - Examples: Bathing, dressing, getting into/out of bed, walking, eating, toileting
- IADLs Instrumental Activities of Daily Living
  - Examples: Using the phone, shopping for groceries on your own, managing medication, cleaning your home, managing money and paying bills



# Factors for selecting a PIT screening tool include length, uniformity, and priority domains


- Length: The PIT screening should be shorter than a full screening tool in order to screen the entire waitlist for priority needs in an efficient way
- Uniformity: The tool will be used across waivers, and so it should be applicable to a broad array of population characteristics and consumer needs
- Priority domains: The tool needs to be aligned with the goals of the screening, including identifying consumers with the most immediate need and referring them to other community-based services. The screening should therefore at least measure the following areas: ADLs, IADLs, informal supports, cognition, health status, and behavioral health status.



#### **Definitions**

- ADLs: Activities of Daily Living routine activity that are generally expected to be completed daily (bathing, dressing, getting into/out of bed, walking, eating, toileting)
- IADLs: Instrumental activity of daily living complex activity required for independent living (using the phone, shopping for groceries on your own, managing medication, cleaning your home, managing money and paying bills).
- Informal supports: Assistance with daily tasks provided by family and friends
- Cognition: Ability to make decisions regarding day-to-day activities and tasks
- Health status: Medical conditions and associated needs (e.g. hypertension, turning/positioning, tube feeding)
- Behavioral health status: Mental health conditions and associated needs (e.g. depression, loneliness, emotional outbursts)








