### **Iowa Integration Campaign**

The Iowa Board of Pharmacy is pleased to announce statewide support to help healthcare providers integrate Iowa Prescription Monitoring Program (PMP) data and NarxCare analytics into approved Electronic Health Records (EHR) and Pharmacy Management System (PMS), using Bamboo Health's PMP Gateway solution. The Iowa Board of Pharmacy will cover the licensing fees associated with the integration service for providers in Iowa that elect to connect their EHR or PMS to PMP Gateway.

### Longer Engagement with MOUD Leads to Better Outcomes for Patients

A study of Medicaid patients conducted by researchers at the University of Wisconsin Madison School of Medicine and Public Health found that the longer individuals with opioid use disorder (OUD) are treated with medication for opioid use disorder (MOUD) the less likely they are to overdose. The study looked at treatment overdose data from Wisconsin and 10 other states with high opioid overdose deaths.

# Drug Enforcement Administration Toxicology Testing Program Releases Quarterly Report

Between January 1, 2022 and March 31, 2022, 104 biological samples and 1 drug product were submitted to the Drug Enforcement Administration Toxicology (DEA TOX). The samples were submitted by 13 states, including Iowa. DEA TOX then analyzed these samples for new psychoactive substances, traditional illicit drugs, and prescription or over the counter drugs.

From the submitted samples, DEA TOX identified and confirmed a total of 580 drugs and metabolites. These drugs and metabolites consisted of 65 new psychoactive substance detections, 216 traditional illicit drug detections, and 278 prescription or over the counter drug detections during this reporting period

# Study Finds Mailing At-Home Kits Improves Safe Disposal Rates for Leftover Opioid Prescriptions

Researchers from the Perelman School of Medicine at the University of Pennsylvania started a program that mailed patients of orthopedic and urologic procedures kits to safely dispose of leftover opioid pain pills. The researchers found this method significantly increased self-reported disposal as compared to patients who were only notified about nearby disposal locations and were not sent an at-home disposal kit.

Researchers aimed to target leftover opioid medications as they are considered a concern because of their potential to be misused by the individual for whom the medications were prescribed or diverted to someone else.
