### CIRCULAR LETTER NO. 127DD-FO

ISSUED BY: Bureau of Child Support Recovery Division of Field Operations

SUBJECT: RC-0079, "HHS Poverty Guidelines," revised.

#### Summary

This letter is to announce the annual update of the poverty guidelines issued by the federal Department of Health and Human Services.

The Child Support Recovery Unit uses these guidelines to determine whether a person meets hardship criteria for mandatory income withholding.

This determination uses the poverty level for a one-person household, as established by these guidelines. The gross annual income poverty level has increased from \$12,060 (2017) to \$12,140. The hardship allowance has increased from \$24,120 to \$24,280.

Use the 2018 guideline amount in making any determinations on or after April 1, 2018. It remains in effect until superseded by a subsequent circular letter announcing the next annual update.
