## SUBJECT: PROMISE JOBS MEMO #159 - Implementation of a Waiting List for the On-the-Job Training Component

## DATE: October 1, 2001

Due to the State's budget situation and the need to ensure that we manage our limited resources, it has become necessary to implement a waiting list for the PROMISE JOBS component, On-the-Job Training (OJT).

Effective immediately, participants may be enrolled in all PROMISE JOBS components except for the OJT component. If OJT is appropriate for a participant, place this participant on the waiting list as of the date a Family Investment Agreement (FIA) is signed. Participants on the OJT waiting list are expected to actively participate in PROMISE JOBS in accordance with their FIA.

Discontinue any negotiations to establish new OJT contracts immediately and amend FIAs as necessary. If a contract with the OJT employer has been signed, honor that contract regardless of the established beginning date. Do not proceed on any contract that is not signed.

Current OJT placements may continue for the life of the contract in existence. Do not renew or extend the duration of an OJT training period. Since OJT contracts are limited to a 6-month period of time, no OJT contracts should exist after March of 2002.

DHS will notify IWD/PROMISE JOBS when the waiting list can be lifted and the appropriate procedures to follow.
